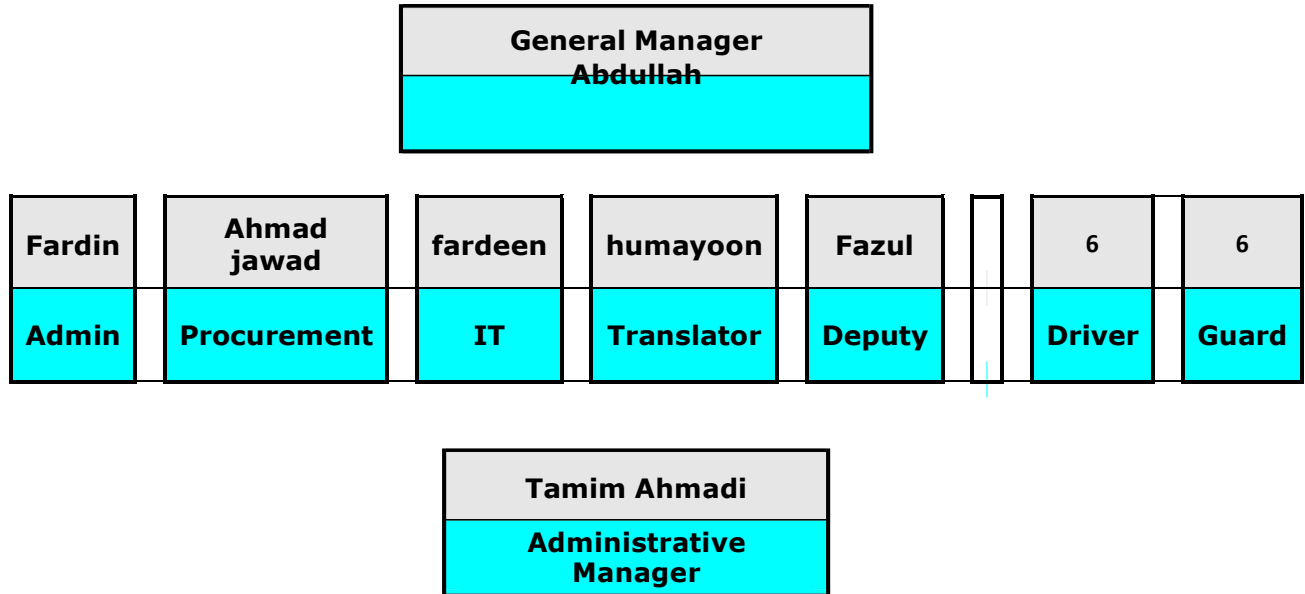

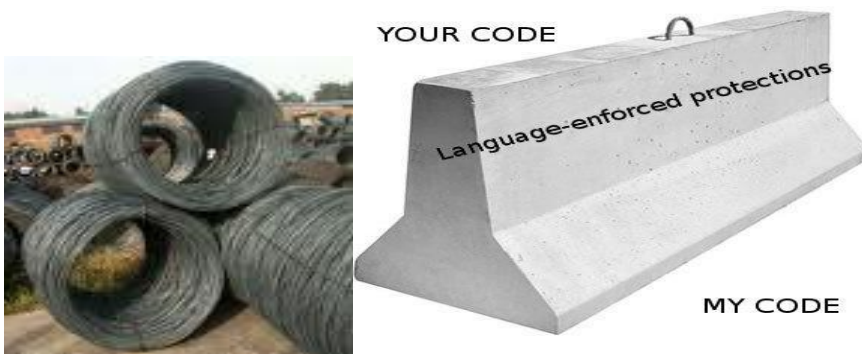

Obligation of License Holder: the holder of the license shall be obliged to comply with the Constitution, Law and Regulations of the Islamic Republic of Afghanistan. In case of any violation, AISA may terminate, confiscate, suspend, amend, nullify, invalidate or redistribute the license.

Prohibitions and Restrictions: Investment shall be prohibited in the field of nuclear energy, establishment of casinos, or similar establishments, production of drugs (narcotics) or other intoxicants, or other acts deemed a crime by the Penal Code. Investment in the fields of production and sale of weapons, ammunition and explosive, non-banking finance activities, insurance activities, natural resources and Infrastructure, including telecommunication facilities, pipeline construction and erection shall be subject to special (relevant) laws.

Reporting: A license holder shall be obliged to notify AISA of any change in its ownership, capital structure, or contribution of additional capital, address and structure of the company, commencement or delay in activities of the company and the reasons therefore. In addition, s/he shall submit the companies' annual report within 90 days of the end of the fiscal year to AISA (from 21st of March until 20 of June).

No Liability: AISA and its branches shall have no liability to any person, including a license holder, to compensate losses/damages which includes without limitation, loss of profit, delay or suspension of employment, losses in formation of business, harmful reliance (sic), consequential or incidental damage to a third person or any other material loss. In addition, nothing in this License shall be regarded as a guarantee or any other form of compensation for damages/Losses.
