INTRODUCTION:

The Welfare Association for the Development of Afghanistan (WADAN) is a non-governmental, non-political, not for profit and independent organization, operating in 34 provinces of Afghanistan inhealth, education, community development and others. We are currently implementing a number of projects in different regions of Afghanistan.

SUMMARY:

WADAN is providing critical assistance in two provinces: Laghman and Hirat. Our primary focus will be on two districts in each province, namely Alishang and Alingar in Laghman, and Injil and Guzara in Hirat. These districts have been identified as priority areas by both the Afghanistan ICCT Winter Prioritization 2023 and FSAC (Food Security and Agriculture Cluster) prioritization.

WADAN's intervention strategy involves the distribution of food assistance (in-kind) to households falling within IPC Phase 3. WADAN plans to distribute these essential food baskets to a total of 4,680 households in three rounds during December, January, and February. This effort will specifically target 1,170 households in each of the selected districts. WADAN will be prioritizing the most deserving and vulnerable individuals through close collaboration with regional clusters, local Shuras, civil activists, and influential community figures.

This targeted approach ensures that our assistance reaches those in urgent need, aligning with the broader efforts of the humanitarian community and local stakeholders to address food security challenges in the identified priority areas.

MINIMUM ELIGIBILITY REQUIREMENTS VENDORS:

To qualify for this RFQ, the vendor must:

TAXES:

Withholding Tax on Subcontractor:

- Government withholding Tax: Pursuant to Article 72 in the Afghanistan Tax law effective March 21, 2009.
- WADAN is required withhold "contractor" taxes from the gross amount payable to allAfghan forprofit subcontractor/vendors with aggregate amount of AFN 500,000.000r greater and transfer this to the Ministry of Finance. In accordance with this requirement, WADAN shall withhold 2% tax from all gross invoices from subcontractors/vendors under this Agreement with active AISA or Ministry of Commerce License.

- WADAN may cancel solicitation and not award and may reject any or all responses received.

CERTIFICATION OF INDEPENDENT PRICE DETERMINATION:

- a) The offeror certifies that--

OTHER CONDITIONS:

- 1. The provider company should be legally registered and affiliated with the Government and have a registration certificate and company bank account.
- 2. The company has to provide the quotation according to the specification of an official quotation form of WADAN.
- 3. Prices should be given in Afghanis and must include all duties, transport cost, loading and unloading costs. Offers without sign and stamp will not be accepted
- 4. The company has to provide the contracted items for WADAN on the head oftime and no delay is accepted in delivery. In case of delay without any logical reasons in delivery of items or completion of work, 0.5% of total cost of undelivered items/unperformed work will be charged as penalty for each day of delay.
- 5. The RFQ and the orders will be distributed to suppliers either by sending in their emailID or giving them an as hard copy.
- 6. If the submission is in hard-copy, the company must mention its full ID at the back of the envelope and envelop is seal /lock and stamped in which they submit their RFQ and quotations.
- 7. An amount of 2% tax will be deducted from the total amount of the contract from company who have a Business License.
- 8. The payment of the procurement will be done via Bank or Check basis to the company after completion of the procurement and validation of procurement committee of WADAN.
- 9. The supplier should submit the proven experience with the application to WADAN's procurement unit.
- 10. WADAN will not be responsible for any changes occurred during the contract such asincrement in custom duties, exchange rate etc...
- 11. The Contract quantity is flexible, i.e., can be increased or decreased based on program requirements. Per Unit cost of contract is valid and it will apply to the total requested quantity of contract.

PAYMENT:

The vendor will be paid after dispatching the food baskets to 4,680 households to the above-mentioned districts during the course of three months or after the completion of each batch.

Sample Check:

Following the bid opening process, vendors meeting the minimum criteria will be invited to undergo a technical evaluation. As part of this evaluation, vendors will be requested to provide samples of the items for further scrutiny.

SELECTION CRITERIA:

The selection criteria of the vendors are based on having the best quality, lowest price and relevant experience.
