SUMMARY:

WADAN is operating residential and outpatient drug treatment centers for women, female adolescents, and children across the four provinces of Kabul, Nangarhar, Farah, and Badakhshan in Afghanistan that are funded through the Colombo Plan Drug Advisory Program (CPDAP) with financial support from the U.S. Department of State's Bureau for International Narcotics and Law Enforcement Affairs (INL). The purpose of these projects is to facilitate the delivery of drug prevention, treatment, and rehabilitation services to drug users where drug dependents, mainly women, children, and adolescent females through residential and outpatient treatment and aftercare services according to a standardized treatment plan.

Presently WADAN manages treatment and rehabilitation centers for women, children, and female adolescent drug dependents and collaborates as the implementing agency with the government of Afghanistan, international organizations, and donors in programs based on reducing, preventing, and treating drug dependency. In Kabul, WADAN has a 60-bed residential treatment center for women, female adolescents, and children, with outpatient services for drug users, similarly, there is a 60-bed inpatient center in Nangarhar, 35 beds at the Farah Center and one with 70 beds in the Baharak district of Badakhshan for adult women, female adolescents, and children. Badakhshan also has one outpatient drug treatment center.

Tender:

The Welfare Association for the Development of Afghanistan (WADAN) is willing to enter into a Blanket Purchase Agreement with a qualified company to support the operations of above listed centers.

MINIMUM ELIGIBILITY REQUIREMENTS FOR VENDORS FOR BID OPENING:

To qualify for this RFQ, the vendor must:

- Hold a valid business license (logistics).
- Bank Statements on vendor Name.
- Similar contract.

TAXES:

Withholding Tax on Subcontractor:

- Government withholding Tax: Under Article 72 in the Afghanistan Tax law effective March 21, 2009.
- WADAN is required to withhold "contractor" taxes from the gross amount payable to all Afghan for-profit subcontractors/vendors with an aggregate amount of AFN 500,000.00 or greater and transfer this to the Ministry of Finance. By this requirement, WADAN shall withhold 2% tax from all gross invoices from subcontractors/vendors under this Agreement with active AISA or Ministry of Commerce License. For subcontractors /vendors without active AISA or Ministry of Commerce license, WADAN shall withhold seven percent 7% "contractor" tax per current Afghanistan Tax law.

DISCLAIMERS AND PROTECTION CLAUSES:

- WADAN may cancel the solicitation and not award and may reject any or all responses received.
- Insurance of solicitation does not constitute award commitment by WADAN.
- WADAN reserves the right to disqualify any offer based on the offeror's failure to follow solicitation instructions.
- WADAN will not compensate offerors for responses to solicitation and reserves the right to issue awards based on the initial evaluation of offers without further discussion.
- WADAN reserves the right to waive minor proposal deficiencies that can be corrected prior to award determination to promote competition
- WADAN will be contacting offerors to confirm the contact person and address and that bid was submitted from the solicitation

CERTIFICATION OF INDEPENDENT PRICE DETERMINATION:

- a) The offeror certifies that--

As an authorized agent does certify that the principals of the offeror have not participated, and will not participate, in any action contrary to subparagraphs (a) (1) through (a)(3) Above; and as an agent, has not personally participated, and will not participate, in any action contrary to subparagraphs (a)(1) through (a)(3) above.

 - o Discovery of any violation after award to the offeror will result in the termination of the award for default.
