The initial period of this contract will be for three months after which could be extended to a one-year contract if Caritas Germany Country Office is satisfied with the quality of the service delivered.

Note for Suppliers:

The company should provide the quotation for Diesel fuel as per specifications below:

- Supply of fuel (Diesel) for the use in Generators and Heaters.
- Quality and Brand: **TURKMAN** (Turkmenistan)
- Standard fuel; Diesel Uncontaminated with a maximum tolerable Impurity: **0.0% up to 3.0%** at a maximum temperature of 28.5' C. (As per quality checking of Fuel analyzer)

The fuel suppliers who intend to submit their filled RFQ to Caritas Germany office must also submit a sample of their fuel (Diesel Only) for quality testing in a small sealed bottled. The bottle must be labelled with the name of supplier's company for the further reference.

COA has a minimum monthly estimated requirement of 3,000 liters during the three months of winter and 15,00 liters in the summer.
