## Background:

The Aga Khan Health Services – Afghanistan herein referred to as "Client" invites sealed bids (technical & price bids in one envelope) from eligible bidders for the procurement of <u>Printing of HMIS</u> <u>Forms</u>.

National Competitive Bidding (NCB) will be conducted in accordance with AKHS-A Single-Stage One-Envelope Bidding Procedure and is open to all Bidders who have experience relevant to this procurement, the specifications, delivery requirements, and other terms and conditions are reflected in the Bidding Document.

Eligible bidders with the following key qualifications should participate in this bidding:

No.	Item	Criteria
1	1 Valid Business license	Valid Business License to be from AISA or esteemed Ministry of Commerce.
2	Execution of One Similar Single Contract	Bidders must provide evidence of having executed at least One Single Contract of similar nature (printing) within the any of the <u>last 5 years</u> (2019 - 2023) the amount of such contract shall <u>not be less than AFN</u> 6,000,000 or equivalent to USD.
3	Liquidated Assets (cash in hand)	The amount of such cash shall <u>not be less than AFN 3,000,000 or</u> equivalent to USD.

Should any of the information data submitted by the bidder in the documents be unclear and not substantiated by supporting documents, such information shall not be considered for evaluation.

Delivery of Bids: Completed documents (Technical & Price Bids) sealed in a single envelope clearly marked as "TECHNICAL BID AND PRICE BID" with the Package name.

## Important notes:

- a) Bids shall be submitted in hard copy at the location and address as described in the bidding document. Electronic submission of the bids **will NOT** be accepted.
- b) Bidders are required to submit bids in person or courier on or before the deadline: <u>21/March/2024 at 10:00 AM</u> together with a Bid Security in the form of bank guarantee (as per the attached form in the bid document) with an amount of <u>not less than AFN 240,000</u> or equivalent to USD. The validity of such bid security shall <u>not be less than 28 days after</u> the expiry of the bid validity period.
- c) The bids will be opened on <u>21/March/2024</u> at <u>10:00 AM</u> in the presence of the bidders' designated representatives who chooses to attend.
- d) A pre-bid meeting shall not be held.
- e) The Client will NOT consider any bids that arrive after the deadline for submission of bids. Any bids received after the deadline for submission of bids shall be declared late, rejected, and returned unopened to the bidder.
- f) The Client will not be responsible for any cost or expenses incurred by Bidders in connection with the preparation and delivery of their bids.
