## **[INTRODUCTION]**

Modifications to address specific Project or Contract needs should be provided only in the Special Conditions of Contract as amendments to the Conditions of Contract. If modifications must be made to the bidding procedures, they can be presented in the Bidding Data Sheet.*
- (d) *The foot-notes and the italic texts between brackets are not part of the text, but rather contain instructions for the user, as does and this Introduction. **They should not be incorporated in the bidding documents.** The cover should be modified as required to identify the bidding documents as to the names of the Project, Contract, and Employer, in addition to the date of issue.*
- (e) *The standard documents have been prepared for bidding where post-qualification applies; adaptations are necessary to ITB Clause 4 and corresponding Bidding Data Sheet, and Forms when prequalification has taken place. The process of prequalification of bidders is not covered in these standard documents.]*

<b>A. GENERAL</b>	
<b>1. Scope of the Bid</b>	<p>1.1 The Employer, as defined in the <b>Bidding Data Sheet (BDS)</b>, invites bids for the Services, as described in the Appendix A to the Contract. The name and identification number of the Contract is <b>provided in the BDS</b>.</p> <p>1.2 The successful Bidder will be expected to complete the performance of the Services by the Intended Completion Date <b>provided in the BDS</b>.</p> <p>1.3 Throughout these Bidding Documents:</p> <ul style="list-style-type: none"> <li>(a) the term "in writing" means communicated in written form (e.g. by email, fax, telex) with proof of receipt;</li> <li>(b) if the context so requires, "singular" means "plural" and vice versa;</li> <li>(c) "day" means calendar day.</li> </ul>
<b>2. Source of Funds</b>	<p>2.1 The Employer guarantees that adequate funds have been budgeted and allotted and are also available for managing the procurement proceedings toward the cost of the project. The Purchaser intends to apply a portion of the Project funds <b>as</b> to eligible payments under the contract for which this Bidding Documents are issued.</p>
<b>3. Eligible Bidders</b>	<p>3.1 The bidder and his / her partners have the citizenship of any country by observing, restrictions in the BDS. If the bidder, contractor and a subcontractor, resident, or registered in a country or operates in accordance with the laws of that country, he is considered a citizen of that country. The origin of any materials, equipment, and services to perform this contract are eligible from the country. Any materials, equipment, and Services to be used in the performance of the Contract shall have their origin in eligible source countries.</p> <p>3.2 All bidders shall provide in Section 3, Bidding Forms, a statement that the Bidder, directly or indirectly, with the consultant or any other entity that has prepared the design, specifications, and other documents for the Project or being proposed as Project Manager for the Contract. A firm that has been engaged by the GAAC PD to provide Consultant Services for the preparation or supervision of the Services, and any of its affiliates, shall not be eligible to bid.</p> <p>3.3 Strictly prohibited to make any withdrawal from the project budget for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import, to the knowledge of</p>

	<p>the GoA, is prohibited by a decision of the United Nations Security Council, taken under Chapter VII of the Charter of the United Nations.</p>
	<p>3.4 The GAAC PD may not be award a contract with a debarred or under the debar bidders.</p>
<p><b>4. Qualification of the Bidder</b></p>	<p>4.1 All bidders shall provide in Section 3, Bidding Forms, a preliminary description of the proposed work method and schedule, including drawings and charts, as necessary.</p> <p>4.2 All bidders shall include the following information and documents with their bids in Section 3, unless otherwise stated in the <b>BDS</b>:</p> <ul style="list-style-type: none"> <li>(a) copies of original documents defining the constitution or legal status, place of registration, and principal place of business; written power of attorney of the signatory of the Bid to commit the Bidder;</li> <li>(b) total monetary value of Services performed for any of the last five (5) years;</li> <li>(c) experience in Services of a similar nature and size for any of the last five (5) years, and details of non- consultancy Services performed or ongoing (70% completed) under way or contractually committed; and names and address of clients who may be contacted for further information on those contracts;</li> <li>(d) list of major items of equipment proposed to carry out the Contract;</li> <li>(e) qualifications and experience of key site management and technical personnel proposed for the Contract;</li> <li>(f) reports on the financial standing of the Bidder, such as profit and loss statements and auditor’s reports for the past five (5) years;</li> <li>(g) evidence of adequacy of working capital for this Contract (access to line(s) of credit and availability of other financial resources);</li> <li>(h) authority to the Employer to seek references from the Bidder’s bankers;</li> <li>(i) information regarding any litigation, current or during the last five (5) years, in which the Bidder is involved, the parties concerned, and disputed amount; and</li> <li>(j) Information about the award of subcontract</li> </ul> <p>4.3 In procurement of renting properties different criteria may not be</p>

	<p>4.4 Bids submitted by a joint venture of two (2) or more firms as partners shall comply with the following requirements, unless otherwise stated in the <b>BDS</b>:</p> <ul style="list-style-type: none"> <li>(a) the Bid shall include all the information listed in ITB Sub-Clause 4.2 above for each joint venture partner;</li> <li>(b) the Bid shall be signed so as to be legally binding on all partners;</li> <li>(c) the Bid shall include a copy of the agreement entered into by the joint venture partners defining the division of assignments to each partner and establishing that all partners shall be jointly and severally liable for the execution of the Contract in accordance with the Contract terms;</li> <li>(d) one (1) of the partners shall be nominated as being in charge, authorized to incur liabilities, and receive instructions for and on behalf of any and all partners of the joint venture; and</li> <li>(e) the execution of the entire Contract, including payment, shall be done exclusively with the partner in charge.</li> </ul>
	<p>4.5 To qualify for award of the Contract, bidders shall meet the following minimum qualifying criteria:</p> <ul style="list-style-type: none"> <li>(a) annual turnover volume of Services of at least the amount <b>specified in the BDS</b>;</li> <li>(b) experience as prime contractor in the provision of at least one (1) service contracts of a nature and complexity equivalent to the Services over the last five (5) years (to comply with this requirement, Services contracts cited should be at least seventy (70) percent complete) <b>as specified in the BDS</b>; the contract under dispute or the dispute amount is 10 percent of total contract price shall not have considered as a similar experience.</li> <li>(c) liquid assets and/or credit facilities, net of other contractual commitments and exclusive of any advance payments which may be made under the Contract, of no less than the amount specified in the <b>BDS</b>.</li> </ul>
	<p>4.6 The GAAC Holding may determine qualification criteria renting properties according to the nature of the procurement determined.</p> <p>A consistent history of litigation or arbitration awards against the Applicant or any partner of a Joint Venture may result in</p>



	<p>disqualification.</p> <p>4.7 The figures for each of the partners of a joint venture shall be added together to determine the Bidder’s compliance with the minimum qualifying criteria of ITB Sub-Clause 4.4(a), (b) and (e); however, for a joint venture to qualify the partner in charge must meet at least forty (40) percent of those minimum criteria for an individual Bidder and other partners at least twenty-five (25) percent of the criteria. The total eligibility figures of the partners must meet at least (100) percent of the eligibility criteria. Failure to comply with this requirement will result in rejection of the joint venture’s Bid.</p> <p>4.8 Subcontractors’ experience and resources will not be taken into account in determining the Bidder’s compliance with the qualifying criteria, unless otherwise <b>stated in the BDS</b>.</p>
<p><b>5. One Bid per Bidder</b></p>	<p>5.1 Each Bidder shall submit only one (1) Bid, either individually or as a partner in a joint venture. A Bidder who submits more than one (1) Bid (other than as a subcontractor or in cases of alternatives that have been permitted or requested) will cause all the proposals with the Bidder’s participation to be disqualified.</p>
<p><b>6. Cost of bidding</b></p>	<p>6.1 The Bidder shall bear all costs associated with the preparation and submission of his Bid, and the Employer will in no case be responsible or liable for those costs.</p>
<p><b>7. Site Visit</b></p>	<p>7.1 The Bidder, at the Bidder’s own responsibility and risk, is encouraged to visit and examine the Site of required Services and its surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the Services. The costs of visiting the Site shall be at the Bidder’s own expense.</p>

	<p>Section 9 Contract Forms</p> <p>8.2 The Bidder is expected to examine all instructions, forms, terms, and specifications in the bidding documents. Failure to furnish all information required by the bidding documents or to submit a bid not substantially responsive to the bidding documents in every respect will be at the Bidder’s risk and may result in the rejection of its bid. Sections 3, 5, and 9 should be completed and returned with the Bid in the number of copies specified in the <b>BDS</b>.</p>
<p><b>9. Clarification of Bidding Documents</b></p>	<p>9.1 A prospective Bidder requiring any clarification of the bidding documents may notify the Employer in writing or by email at the Employer’s address indicated in the invitation to bid. <b><u>The Employer will respond to any request for clarification received earlier than four (4) days prior to the deadline for submission of bids. The purchaser must respond to any request for clarification within 2 days</u></b> of receipt. Copies of the Employer’s response will be forwarded to all purchasers of the bidding documents, including a description of the inquiry, but without identifying its source.</p> <p>9.2 To clarify issues and to answer questions on any matter arising in the Bidding Documents, the Employer may, if stated in the BDS, invite prospective Bidders to attend a Pre-Bidding Meeting at the place, date and time as specified in the BDS. Bidders are encouraged to attend the meeting if it is held. The Bidder is requested to submit any questions in writing so as to reach the Employer not later than five (5) days prior to the date of the meeting. Minutes of the pre-Bidding meeting, including the text of the questions raised and the responses given, together with any responses prepared after the meeting, will be transmitted within five (5) days to all those who purchased the Bidding Documents.</p>
<p><b>10. Amendment of Bidding Documents</b></p>	<p>10.1 Before the deadline for submission of bids, the Employer may modify the bidding documents by issuing addenda.</p> <p>10.2 Any addendum thus issued shall be part of the bidding documents and shall be communicated in writing or by email to all purchasers of the bidding documents. Prospective bidders shall acknowledge receipt of each addendum by email to the Employer.</p> <p>10.3 To give prospective bidders reasonable time in which to take an addendum into account in preparing their bids, the Employer shall extend, as necessary, the deadline for submission of bids, in accordance with ITB Sub-Clause 20.2 below.</p>

Supporting documents and printed literature furnished by the Bidder may be in another language provided they are accompanied by an accurate translation of the relevant passages in the language specified in the Bidding Data Sheet, in which case, for purposes of interpretation of the Bid, the translation shall govern.</p>
<p><b>12. Document Comprising the Bid</b></p>	<p>12.1 The Bid submitted by the Bidder shall comprise the following:</p> <ul style="list-style-type: none"> <li>(a) The Form of Bid (in the format indicated in Section 3);</li> <li>(b) Bid Security;</li> <li>(c) Priced Activity Schedule;</li> <li>(d) Qualification Information Form and Documents;</li> <li>(e) Alternative offers where invited; and</li> <li>(f) Beneficial Ownership Discloser form and</li> <li>(g) Any other materials required to be completed and submitted by bidders, as <b>specified in the BDS</b>.</li> </ul> <p>12.2 Bidders bidding for this contract together with other contracts stated in the IFB to form a package will so indicate in the bid together with any discounts offered for the award of more than one contract.</p>
<p><b>13. Bid Prices</b></p>	<p>13.1 The Contract shall be for the Services, as described in Appendix A to the contract and in the Specifications, Section 8, based on the priced Activity Schedule, Section 5, submitted by the Bidder.</p> <p>13.2 The Bidder shall fill in rates and prices for all items of the Services described in the in Specifications (or Terms of Reference), Section 8 and listed in the Activity Schedule, Section 5. Items for which no rate or price is entered by the Bidder will not be paid for by the Employer when executed and shall be deemed covered by the other rates and prices in the Activity Schedule.</p> <p>13.3 All duties, taxes, and other levies payable by the Service Provider under the Contract, or for any other cause, shall be included in the total Bid price submitted by the Bidder.</p> <p>13.4 If <b>provided for in the BDS</b>, the rates and prices quoted by the Bidder shall be subject to adjustment during the performance of the Contract in accordance with and the provisions of Clause 6.6 of the General Conditions of Contract and/or Special Conditions of Contract. The Bidder shall submit with the Bid all the information required under the Special Conditions of Contract and of the</p>

	General Conditions of Contract.
<p><b>14. Currencies of Bid and Payment</b></p>	<p>13.5 For the purpose of determining the remuneration due for additional Services, a breakdown of the lump-sum price shall be provided by the Bidder in the form of Appendices D and E to the Contract.</p> <p>14.1 The lump sum price shall be quoted by the Bidder in Afghanis, unless specified otherwise in the BDS.</p>
<p><b>15. Bid Validity</b></p>	<p>15.1 Bids shall remain valid for the period <b>specified in the BDS</b>. In national competitive bidding bid validity shall not be less than (90) days. In international competitive bidding bid validity shall be at least (120) days.</p> <p>In exceptional circumstances, the Employer may request that the bidders extend the period of validity for a specified additional period. The request and the bidders' responses shall be made in writing or by email. A Bidder may refuse the request without forfeiting the Bid Security. A Bidder agreeing to the request will not be required or permitted to otherwise modify the Bid, but will be required to extend the validity of Bid Security for the period of the extension, and in compliance with ITB Clause 16 in all respects.</p>
<p><b>16.
