Important points about animals:

1. Time for arranging the animals: After awarding the contract the supplier must complete all the distribution within 20 days.
2. Time of Quarantine: After arrival at the warehouse there should be at least 5 to 10 days of quarantine to inspect the female goats and the supplier should provide all the services (Feeding, Water, etc.)
3. Feeding for the time of Quarantine: Suppliers must provide feeding during the quarantine time to keep female goats healthy.
4. vaccines must be administered to all goats during the quarantine period in front of IRW staff and DAIL representative, before distribution to rightsholders.
5. Vaccines enterotoxemia and PPR to each Milk Goat must be administered to all Milk Goats during the quarantine period in front of period IRW staff and DAIL representative, before distribution to rightsholders.

6. Inspection time: Whenever a supplier provides more than 100 female Goats the inspection will take place and the supplier should immediately remove rejected female Goats from inside the warehouse.
7. Location of inspection? The inspection location must be inside Kandahar province.
8. Arrangements are needed in place for handling live animals: A proper warehouse with all the essential requirements should be in place like (good condition rooms, feeding/water system)
9. Transportation mechanism: Normal transportation (in large trucks) from stock to distribution point.
10. The supplier must get the female sheep to the distribution point (1) hour before distribution time and must be take care of the animals until distribution is finished in case any animal is missing during the distribution vendor is responsible for the death or injury animals in such cases vendor is responsible for replacement.
