The supplier is responsible for all costs associated with preparing and submitting their quotation. The Human Rights Watch and Media Organization will not be responsible or liable for these costs, regardless of the outcome of the negotiation.

Eligibility and Qualification Requirements

Suppliers in the situations listed in article 14 of the General Terms and Conditions for Supply Contracts are not eligible.

In the Quotation Submission form, suppliers must confirm that they meet the eligibility criteria mentioned above. If requested by the Human Rights Watch and Media Organization, the supplier whose quotation is accepted must provide satisfactory evidence of its eligibility through competent authorities in its country of establishment or operation. If such documents are not available, the suppliers must reject them.

Suppliers must also certify that they comply with Human Rights Watch and Media Organization's Child Protection Policy", as stated in the end.

Suppliers must provide the information and documents requested by Human Rights Watch and the Media Organization to demonstrate their capability and adequate resources.

Exclusion from award of contracts

Contracts may not be awarded to Candidates who, during this procedure:

- 1. Are subject to conflict of interest:
- 2. Are guilty of misrepresentation in supplying the information required by the Human Rights Watch and Media Organization as a condition of participation in the Contract procedure or fail to supply this information.

Documents Comprising the Request for Quotation

The Supplier shall complete and submit the following document with his quotation:

- 3. National Identity Card
- 4. Valid License
- 5. Relevant past experience documents
- 6. Any other documents required by Human Rights Watch and Media Organization.

Price

The price quoted by the supplier shall not be subject to adjustments on any account except as otherwise provided in the conditions of the Contract.

- Price shall be quoted in AFN
- A 7% tax applies to a non-business license and a 2% tax to a business license, which will be clarified in the contract.

a) Validity

Quotations shall remain valid and open for acceptance for 30 days after the closing date.

b) Closing date

Quotation must be received by the Human Rights Watch and Media Organization as specified on page 1 not later than the closing date and time. Any quotations received after that will not be considered.

c) Award of Contract and Criteria

The Human Rights Watch and Media Organization will award the contract to the supplier whose quotation is deemed to be substantially responsive to this Request for Quotation (RFQ) and who has offered the lowest evaluated price. Additionally, the supplier must have the capability and resources to effectively carry out the contract and provide after-sales service.

The Human Rights Watch and Media Organization reserve the right to accept all or part of your quotation, whichever is in its best financial interest.

d) Signature and Entry into force of the Contract

Before the quotation validity period expires, the Human Rights Watch and Media Organization will notify the successful supplier in writing.

Upon receipt of the unsigned Contract within 2 days, the successful supplier must sign and date it and return it to the Contracting Authority. Once signed by the Contracting Authority, the Contract will come into effect, and the successful supplier will become the Contractor.

If the successful supplier fails to sign and return the Contract within the specified timeframe, the Human Rights Watch and Media Organization may consider the acceptance of the quotation to be canceled. This would not prejudice the Contracting Authority's right to claim compensation or pursue any other remedy for such failure, and the successful supplier will have no claim against the Contracting Authority.

e) Cancellation for Convenience

The Human Rights Watch and Media Organization may for its own convenience and without charge or liability cancel the RFQ at any stage.
