1. Introduction

Muslim Hands International – MHI is an International Relief and Development NGO, established in the United Kingdom in 1993 with the objective of providing relief and emergency services and long-term sustainable development projects in a cultural, ethical, effective, efficient and transparent manner. 1	Supply, transportation, slaughtering, shredding, weighing, and packing of (11) large animals for the upcoming Eid al-Adha-2024. Animal Type: Bull Animal Specification: The supplier is expected to supply healthy animals complying with the following Islamic criteria for Qurbani: 1)The minimum age of the supplied animal must be (2 years). 2)Animal must not be blind or one-eyed. 3)The animal must not be missing a third (or more) of their ear or tail, either through loss or since birth. 4)The animal must not have their horns broken off from its root. 5)The animal must not have a lame leg so that they are unable to walk on it. 6)The animal must not be excessively thin, lean, or sick. 7)The animal must not be toothless or missing over half their teeth. It must have 2 – 4 (not more) teeth. 8)The net weight of the meat of an animal should not be less than 130 kg. Other conditions: The supplier should deliver animals on the night of the 1st day of Eid al-Adha to Bagh Bala Muslim Hands School of Excellence in Kabul. MHI AFG will slaughter animals on the 2nd day of Eid al-Adha. Under this procurement, the supplier is responsible for assigning the required number of butchers (at least 6) and labor (at least 5) for slaughtering, shredding, weighing, and packing of (440) meat parcels each (3 kg).  - ع) شرکت قراردادی همچنان مکلف است بخشهای مازاد و غیر قابل استفاده حیوانات قربانی را به بیرون از محل قربانی انتقال دهد.

3. Minimum Eligibility Requirements for Vendors to be Considered for Further Consideration

- It is mandatory for vendors/suppliers to attend the Pre-bid meetings on 27-May-2024 at MHI
 Main Office, starting at 10:00 AM. During this meeting, a briefing will be provided regarding the
 announced RFQ, including specifications, quality, services, and delivery requirements. Failure to
 attend the Pre-bid Meeting will result in the rejection of the vendor's bids, and their bid will not be
 considered.
- 2. Submit their quotes as per deadline specified in RFQ.
- 3. If a public holiday is announced on the day of the bid opening, the bid opening will be rescheduled to the next working day.
- 4. Hold a valid business license and have valid business bank account in company name.
- 5. Accept all MHI-Afghanistan terms and conditions, including payment and delivery terms.
- 6. Please note that bid submitted on our Request for Quotation (RFQ) must be filled out using our designated company format. Any bid submitted in a different format will be rejected.

4. Conflict of Interest

- MHI requires every prospective Supplier to avoid and prevent conflicts of interest, by disclosing
 to MHI if you, or any of your affiliates or personnel, were involved in the preparation of the
 requirements, design, specifications, cost estimates, and other information used in this RFQ.
 Bidders shall strictly avoid conflicts with other assignments or their own interests, and act without
 consideration for future work. Bidders found to have a conflict of interest shall be disqualified.
- Bidders must disclose in their Bid their knowledge of the following: a) If the owners, part-owners, officers, directors, controlling shareholders, of the bidding entity or key personnel who are family members of MHI staff involved in the procurement functions and/or the Government of the country or any Implementing Partner receiving goods and/or services under this RFQ.
- 3. The eligibility of Supplier that are wholly or partly owned by the Government shall be subject to MHI's further evaluation and review of various factors such as being registered, operated and managed as an independent business entity, the extent of Government ownership/share, receipt of subsidies, mandate and access to information in relation to this RFQ, among others. Conditions that may lead to undue advantage against other Bidders may result in the eventual rejection of the RFQ.

- 3. Will the supplier be able to meet MHI's deadline? Does the number of days or the time period indicated by the supplier to complete the related tasks?
- 4. Does the supplier have the same experience with other NGOs or institutions? If so, please list the NGOs/institutions and indicate if we may contact them.
- 5. Does the RFQ adequately describe in a clear concise, and understandable manner the work to be performed including **sampling** techniques and analytical procedures to be used?

5.2. Information about your company:

a. A short profile of your company with emphasis on the different services you supply. If the company is part of a group of companies, or is a subsidiary or parent company, please also give details of the group. N/A
