1. Introduction

2. Scope of Civil Work

- The cost includes construction 40 borewell in Wardak, Province along with applicable taxes.
- MAXIMUM TIME-FRAME FOR COMPLETION OF WORKS: The construction of 40 borewells must be completed in six months and will start after from the sign of contract.
- Pump Installation: Install a suitable pumping system. Ensure the pump is properly sized and installed according to the project requirements.
- Backfilling around a large-diameter pipe is an essential operation, and it is imperative for the contractor to ensure that it is done properly to a height of 1 meter above the water level.
- If the company does not finish the activities on time, the delay damage percentage is 0.01% of the total contract amount per day of delay.
- The contractor is required to inspect all designated locations chosen by MHI-Afghanistan in close collaboration with the respective PRRD offices to ensure the successful execution of the project.
- If a contractor encounters a situation where any designated location indicates potential success for the DWs project by drilling beyond the estimated depth of 50m, MHI-Afghanistan is amendable to considering such cases. The assessment will take into account locations where the water level is higher, potentially leading to project success at depths lower than 50m, and flexibility exists in MHI-Afghanistan for this change.
- The work will be adjusted during the implementation of the project, if somewhere the water level is 45 meters, we will dig the well at 60 meters, and if the water level is 15 meters, we will dig it at 40 meters.
- If the place of work is normal, the contractor will work as usual, and if there are any problems in the location, the contractor will contract MHI-Afghanistan before starting or relocating the machine. If after our permission the well fails, MHI will have reaction rules and regulations in this regard.
- Preference will be given to vendors with experience in digging wells.
- The exact location, GPS point, and Hand Pump Apron details have been attached for your reference.

3. Minimum Eligibility Requirements for Vendors to be Considered for Further Consideration

1. It is mandatory for vendors/contractor to attend the Pre-bid meetings on **02-June-2024** at MHI Main Office, starting at **10:00 AM**. During this meeting, a briefing will be provided regarding the announced RFQ, including specifications, quality, services, and delivery requirements. Failure to attend the Pre-bid Meeting will result in the rejection of the vendor's bids, and their bid will not be considered.
2. A bid security in Favor of "Muslim Hands Afghanistan" with a total amount of **250,000/-AFN**, equivalent to the bid amount, must accompany the bid as a tender guarantee. Please note that the bid guarantee must be provided through a bank. Once the contract has been awarded to the successful bidder his/her bid security will be converted into a performance guarantee. If any selected bidder refuses to accept the order for the offered packages or refuses to sign the contract, Muslim Hands Afghanistan reserves the right to forfeit the bid security of the bidder. Bids received without the bid guarantee will be rejected.
3. Submit their quotes as per deadline specified in RFQ.
4. Hold a valid business license and have valid business bank account in company name.
5. Accept all MHA-Afghanistan terms and conditions, including payment terms.
6. Please note that bid submitted on our Request for Quotation (RFQ) must be filled out using our designated company format. Any bid submitted in a different format will be rejected.

4. Conflict of Interest

7. MHA requires **every prospective Supplier** to avoid and prevent conflicts of interest, by disclosing to MHA if you, or any of your affiliates or personnel, were involved in the preparation of the requirements, design, specifications, cost estimates, and other information used in this RFQ. Bidders shall strictly avoid conflicts with other assignments or their own interests, and act without consideration for future work. Bidders found to have a conflict of interest shall be disqualified.
8. Bidders must disclose in their Bid their knowledge of the following: a) If the owners, part-owners, officers, directors, controlling shareholders, of the bidding entity or key personnel who are family members of MHA staff involved in the procurement functions and/or the Government of the country or any Implementing Partner receiving goods and/or services under this RFQ.
9. The eligibility of Supplier that are wholly or partly owned by the Government shall be subject to MHA's further evaluation and review of various factors such as being registered, operated and managed as an independent business entity, the extent of Government ownership/share, receipt of subsidies, mandate and access to information in relation to this RFQ, among others. Conditions that may lead to undue advantage against other Bidders may result in the eventual rejection of the RFQ.

4. Does the supplier have the same experience with other NGOs or institutions? If so, please list the NGOs/institutions and indicate if we may contact them.
5. Does the RFQ adequately describe in a clear concise, and understandable manner the work to be performed including **sampling** techniques and analytical procedures to be used?

5.4. Costs:

- a. All cost shall be inclusive of all applicable taxes as per taxation law of the government of Afghanistan, www.mof.af, TA/DA.
- b. The quotation price should be given in AFN

5.5. Payment:

- a. Once the contract is signed with a supplier all the payment will be processed through **Bank transfer**, the supplier is not supposed to request MHA for cash or check payment.
- b. Payment will be made after the submission of the completion report. The payment processing will take place within one month of receipt of the report.
- c. Additionally, the payment will be processed to Partner Company's bank account not individual bank account.

Payment Milestones:

- a. Muslim Hands – Afghanistan (MHI – Afghanistan) will disburse each instalment subsequent to the successful completion of 10 Digging wells (DWs) from the contractor. The completion status will be verified and approved by MHI's designated technical engineer and team.
- b. A portion of 10% from each instalment will be retained by MHI in consideration of work quality assurance and compliance with specified quantities until the conclusion or finalization phase of the project.
- c. Upon satisfactory verification of the quality of completed tasks, MHI will release the withheld 10% amounts after the project's entirety from the contractor's end. Final approval and project closure will be subject to verification by MHI's relevant team and the pertinent Provincial Ruler and Rehabilitation Department (PRRD) office.

6. Submission Procedure

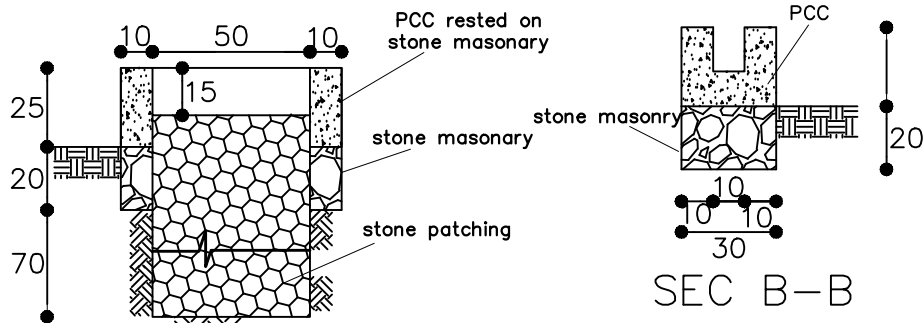
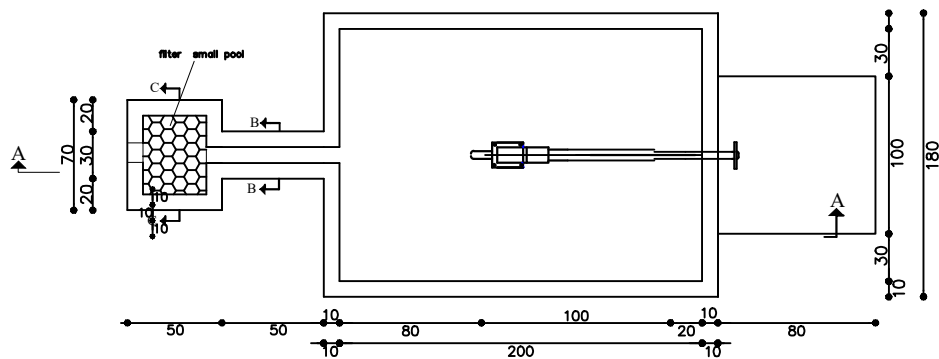

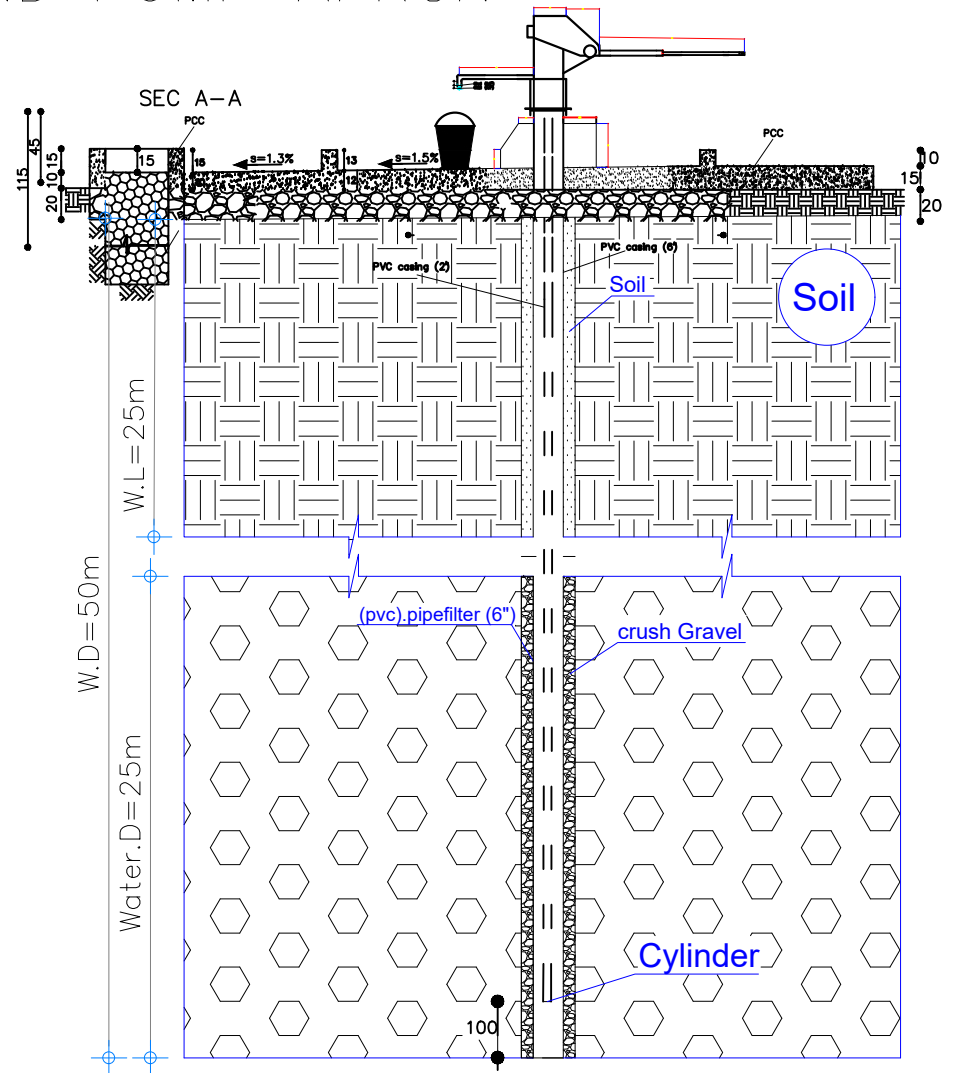
TUBE WELL / HAND PUMP APRON
