1. Scope of Work:

Company is planning to process and interpret the newly acquired 1160 Km firmed 2D seismic data in the Kashkari, Bazarkami and Zaimorudsai blocks. Objective is oilfields evaluation, new structural prospects and leads generation and providing information to research geological and hydrocarbon background in this area. High quality seismic data will be required for Geological & Geophysical studies to evaluate the hydrocarbon potential and find the drillable structural traps in the Kashkari, Bazarkami and Zaimorudsai blocks. Contractor shall carry out the processing and interpretation of 1160 Km 2D seismic data and shall provide personnel, equipment, and services for the Work. The services are required to assess a detailed structural and stratigraphic study of the area for mapping the locations of exploration wells.
