Besides in the 1980s Union Aid was providing health programs in all provinces of Afghanistan.

Currently, Union Aid implements various projects in health, livelihood, education, rehabilitation of basic infrastructures, and humanitarian response projects in more than 13 provinces of Afghanistan.

Terms & Conditions:

1. Tender documents can be collected from **House#01, Street#01, Sector#2, Bagh-e-Bala, Kabul-Afghanistan** from 08:00 AM to 02:00 PM, Sunday to Thursday. The tender pack can also be downloaded from our website [www.unionaid.org](http://www.unionaid.org). Tender documents can also be collected by sending an email request to **logistics@unionaid.org**
2. Sealed tenders should reach **House#01, Street#01, Sector#2, Bagh-e- Bala, Kabul-Afghanistan** or before 01:00 PM hours on 26 June 2024 and should be marked **“TENDER - Not to be opened before 01:30 PM on 26<sup>th</sup> June 2024”**
3. Tenders will be opened on the same day i.e. 26<sup>th</sup> Jun 2024 at Time 1:30 PM hrs. In the presence of suppliers or their representatives, who wish to witness the tender opening.
4. In case a public holiday is announced by the Government (Due to any reason) the tender will be opened the next working day at the same time and venue.
5. **Bid security in favor of “Union Aid” with a value of 2% of the bid amount must also accompany the bid as a Tender Guarantee. Bids received without a Bank Guarantee will be rejected.**
6. Only the shortlisted supplier will be asked for the submission of samples or the bid committee may visit the supplier location for verification of samples.
7. The Supplier must quote only one option for each item. Bids received with more than one option and rates may be rejected.
8. Tender committee reserves the right to change the quantities or cancel/reject any or all offers without assigning any reason, if any selected bidder refuses to accept the order for the offered lot/lots or refuses to sign the contract, Union Aid reserves the right to forfeit the bid security of the bidder.
9. Suppliers must not be engaged in any corrupt, fraudulent, collusive, or coercive practices including but not limited to applying/ bidding by multiple names/companies. If any bidder is found to be involved in such practices his/her bid may be rejected and the companies in question permanently blacklisted
10. Lowest price will not be the sole criteria for selection. Quality, delivery time, and previous experience will also be considered.
11. **All Medical Supplies (Medicine, Medical supplies, CHW Medicine) should have more than 24 months of useful life (Expiry date).**
12. The delivery period for the supply of pharmaceuticals is – **As per Order date.**
