Introduction

Submission Requirements

Proposals must include:

- 1. Company Profile: Overview of the firm, including experience with non-profit organizations.
- 2. Team Composition: Details of the audit team, including qualifications and experience.
- 3. Approach and Methodology: Description of the proposed audit approach and methodology.
- 4. Timeline: Proposed timeline for completing the audit.
- 5. References: Contact information for at least three references from similar NGOs/INGOs.
- 6. Cost Proposal: Detailed breakdown of costs for the audit services, including any additional expenses.

Evaluation Criteria

Proposals will be evaluated based on:

- 1. Experience and Qualifications: Relevant experience in auditing non-profits.
- 2. Approach and Methodology: Suitability and clarity of the proposed audit approach.
- 3. Team Composition: Qualifications and experience of the audit team.
- 4. References: Feedback from provided references.
- 5. Cost: Cost-effectiveness and transparency of the proposal.
