1. Organizational Brief:

ADRA humanitarian organization with a mission to deliver relief and development assistance to individuals regardless of their ethnicity, political affiliation, gender, or religious association.

ADRA Afghanistan belongs to the worldwide ADRA network, working in 5 core sectors: (1) Emergency, (2) Livelihoods, (3) Education and (4) Health and (5) Renewable Energy. ADRA Afghanistan a registered international NGO and active in Afghanistan since 2002, and has delivered numerous projects in various sub-sectors, specifically in Emergency relief including

winterization, Internally Displaced People (IDPs) and Refugees, Safe water drinking, Sanitation & Hygiene promotion, Health Care Institutions management, Capacity Development, Vocational skills training, Literacy (adult/child), Education Institutions Infrastructure, Economic and Income Development.

ADRA Afghanistan is currently, implementing shelter construction project for earthquake affected families project in Zindajan district of Herat province for the earthquake affected families. In total 55 shelter will be constructed for the earthquake affected families by end of October 2024.

2. Scope of Services:

The supplier is required to provide construction materials for 55 transitional shelters according to the specifications outlined in the Bill of Quantities (BoQ) below. The delivery location is in the Zindajan district of Herat province. The selected supplier must ensure that all materials are delivered to the specified distribution location, with transportation costs included in the quote.

1. Provision of Materials:

- The supplier shall supply all necessary construction materials for 55 transitional shelters as detailed in the BoQ.

2. Delivery Location:

- Materials must be delivered to the specified distribution point in the Zindajan district of Herat province.

3. Transportation Costs:

- The supplier must include all transportation costs in the quote, ensuring that materials are delivered on time and in good condition to the designated location.

3. Bill of Quantity:

ADRA Afghanistan is planning to deliver materials for 55 transitional shelters to support earthquake-affected families in Herat province. Each of the 55 families will receive materials for one shelter. The materials for each shelter shall be delivered to the specific location where the shelter is being constructed. 1. All the prices should be inclusive of Transportation, visibility and other miscellaneous costs of any other activity the supplier foresees as cost related, please provide the description underneath for such activities and all materials should be provided as per ADRA Engineer direction
2. Please sign and stamp this page exclusively.
3. All eligible bidders must provide samples of the materials mentioned in the bill of quantity in Herat province, at a designated address upon request from 26th June to 8th July 2024.

4. Instruction to the Bidder:

- a. The bidder must deliver construction materials to various construction sites (each shelter location) in Zindajan district, Herat province, according to the work plan and under the direction of the ADRA engineer throughout the project period.
- b. Quotation cover letter must be signed by the supplier company's authorized person
- c. Bidders must complete the attached Bill of Quantities to submit their quotes. All prices shall be quoted in Afghanis only. RFQs received in any currency other than Afghanis will be considered invalid, and the bidder will be excluded from the bidding process.
- d. In case of price discrepancy between unit price and subtotal price, the unit price shall prevail.
- e. The rates quoted shall be for complete service inclusive of all taxes and all charges for service contingent to the work.
- f. ADRA Afghanistan reserves the right to award the contract to one or multiple vendors, or to none, depending on the project's needs.
- g. The Bidder shall have a valid business license to operate in Afghanistan and must submit the latest tax clearance document as evidence of no pending tax obligations with the Government.
- h. Some materials mentioned in the Bill of quantity may not be necessary, such as soil etc.
- i. The contractor is responsible for providing timely reports on the delivery of construction materials to the shelter locations.
- j. The bidder should visit the project location to obtain all necessary information for completing their offers. No claims for additional costs will be accepted.
- k. Shelter materials may be tested at any time at the request of the ADRA technical team/Engineer. These tests shall be carried out as directed by the Engineer or authorized representative at the specified location. The contractor shall provide the necessary assistance, materials, equipment, instruments, and labor required for such tests. The cost of carrying out these tests shall be borne by the contractor.
- l. Interested eligible bidders should provide samples for each item before the closing date of the RFQ. The samples should be brought to the ADRA Herat office. The office address is mentioned in the RFQ documents.
- m. The project completion date is 31st October 2024.

5. Government Contract Withholding Tax:

Pursuant to Article 72 in the Afghanistan Tax Law effective May 2010, ADRA Afghanistan is required to withhold "contractor" taxes from the gross amounts payable to all Afghan for-profit subcontractors/vendors. In accordance with this requirement, ADRA Afghanistan shall withhold two percent (2%) tax from all gross invoices to subcontractors/vendors under this Agreement with active AISA or Ministry of Commerce license. For subcontractors/vendors without active AISA or Ministry of Commerce license, ADRA Afghanistan shall withhold seven percent (7%) "Contractor" taxes per current Afghanistan Tax Law.

Before the signing of this Agreement, the subcontractor/vendor will provide a copy of the organization's AISA or Ministry of Commerce license and TIN (Tax Identification Number). Amounts deducted from the invoices will be forwarded to the Ministry of Finance (MOF) Tax Division credited to the firm's TIN.

Records of payments to the MoF shall be maintained on file with ADRA Afghanistan.

6. Confidentiality and Conflict of Interest:

- I. It is a further condition of proposing that you will keep confidential the information disclosed to you in this invitation to bid and in connection with the invitation and your response to the invitation.
- II. A supplier/contractor will not be eligible for selection if any of its partners, directors or major shareholders is the staff of ADRA Afghanistan or closely related to it.
- III. A proposing contractor/supplier must declare, as part of the proposal, whether any partners, directors, major shareholders, senior staff, or the partners / spouses of any of these listed are:
 - a. Staff of ADRA Afghanistan or closely related to it.
- IV. Potential bidders should also identify any work they are currently undertaking, or bidding for, which could cause a conflict of interest, and indicate how they will deal with this potential conflict if the contract is awarded.
- V. The supplier may report unethical, illegal, and corrupt practice to ADRA Afghanistan Office.

7. Submission Information for Bidder:

To be considered, your bid submission must include the following information. Failure to provide such information, in the requested format where specified, will result in your proposal not being considered.

8. Pre-bid Meeting:

Bidders or their authorized representatives are invited to attend a pre-bid meeting on July 4, 2024, at 11:00 AM. The meeting will be held online. Interested participants can register by emailing ProgramManager@adra-af.org. The purpose of the pre-bid meeting is to explain the proper procedures for bid preparation and submission, clarify any issues, and answer questions. Companies that do not attend the pre-bid meeting will not have the right to request clarifications after the bid-opening.

Bidding will be conducted through the ADRA procurement policies.

9. Bidding day

Bids must be submitted in a sealed envelope to the below address from 26th June 2024 till 8th July 2024, 03:00 PM (if this date is announced an official holiday, then bids must be submitted next working day at the same time and venue). Electronic bidding shall not be permitted. Late bids will be rejected.

10. RFQ evaluation:

The RFQ will be evaluated using the following technical criteria. Proposals should address each question.

- I. Does the supplier company have a valid license? If yes, please provide us the copies.
- II. Has the supplier company had the same experience with other NGOs or institutions? If so, please list the NGOs/institutions and indicate if we may contact them. (Please provide the contact details with relevant position title)
- III. A short profile of your company with emphasis on the different services you supply. If the company is part of a group of companies, or is a subsidiary or parent company, please also give details of the group.
- IV. Details of your company's experience of providing similar services, and in particular experience of working with similar organization's funded projects in Afghanistan.

10.1 Negotiation:

- I. It is anticipated that a 'Contract' will be awarded solely on the basis of the original offers received. However, ADRA reserves the right to negotiate the price and the terms and

conditions offered by the bidder by requesting clarifications prior to award or proposing adjustments to the quotation.

- II. ADRA reserves the right to conduct a competitive range and to limit the number of Bidders in the competitive range to permit an efficient evaluation environment among the most highly rated quotations. At the sole discretion of ADRA, Bidders may be requested to conduct oral presentation.

10.2 Costs:

All Costs must be provided in AFN. All the prices quoted in the bid documents must be inclusive of the relevant tax applicable as per the Afghanistan taxation law.

11. Payments:

- I. Once the contract is signed with a supplier company all the payment will be processed through bank transfer or on agreed modality with the supplier, the company is not supposed to request ADRA for cash or cheque payment

Payment will be made in four stages or installments as per the purchase order.

- II. Additionally, the payment will be processed to partner supplier company's bank account officially introduced to ADRA not individual bank account.

12. Disclaimer:

ADRA is not bound contractually or in any other way to any Proponent to this request for proposal/bid. The organization is not liable for any costs or compensation in relation to the consideration of this Request for submission of proposal/bids by the Proponents whether or not the organization terminates, varies, or suspends the process or takes any other action permitted under this Request for proposals/bids. The organization may, at its absolute discretion, elect to abandon any part or whole of the process without giving prior notice to the Proponents or potential Proponents.
