2. INFORMATION TO BIDDERS

1. Background

Roots of Peace (ROP) is a humanitarian organization whose mission is to rid the world of landmines and other remnants of war by transforming toxic minefields into thriving farmland and communities through a focus on sustainable, organic farming practices. Roots of Peace is implementing a Community-Based Agriculture Rural Development (CBARD) project to support the Production of Fruits and Vegetables as an alternative to poppy Cultivation and Trade in three high Cultivation provinces of Afghanistan.

Moreover, the ROP-CBARD project aims to create partnerships between existing ROP-CBARD communities to reach three key objectives: reducing opium poppy cultivation, creating alternative licit economic development for former poppy farmers and women in the community, and supporting more sustainable peace.

Failure to adhere to this instruction will lead to the disqualification of a bid from the evaluation. Any quotation sent through any links will lead to the disqualification of a quotation from evaluation.

Thereafter a further 15% of the total contract value to be applied on the 51st day and thereafter every seven days until the vendor completes his contractual obligations.</p>

4. EVALUATION AND AWARD

An award will be made based on the Lowest Price, Technically Acceptable source selection process. The award will be issued to the responsible Offeror submitting the lowest evaluated price that follows the RFQ instructions and meets or exceeds the acceptability requirements/technical requirements described in this RFQ. All received bids will be evaluated based on the initial minimum criteria below. Vendors who do not pass the minimum required criteria will not be considered.

ROP-CBARD will evaluate the following factors as PASS/FAIL:

- **Technical Specification – Please provide technical specifications of the items along with their origin & pictures, the goods offered should meet or exceed the RFQ requirements.**
- **Submission of current and valid MOCI License.**
- **Submission of Banking / Payment information. (Only AFN Accounts will be accepted)**
- **At least two successful contracts have been completed in the last five years in providing similar/relevant goods/services. It's a requirement to attach the copies of relevant past contracts as evidence.**
- **Certificate of origin to certify that that the offered seeds are from a valid source of origin.**
- **Physical Inspection certificate from the seed planting material certification department of MAIL or Phytosanitary certificate for imported seeds. Companies that will not provide the certification shall be disqualified from further evaluation.**
- **Proof of financial capability, a bank statement for the last six months with a closing balance of at least 25% of the total cost offered. The statement closing balance date should be July 10, 2024. Or a letter of credit from the bank for the total cost is also acceptable.**

Vendors who pass the initial screening based upon the criteria above will proceed to the Lowest Price Technically Acceptable evaluation to determine the successful offer. ROP/CBARD reserves the right to increase and or decrease the requirement during the evaluation and or award stage. The ROP/CBARD reserves the right to conduct sample check during the evaluation. All goods shall be high quality products, low quality products will not be accepted.
