Bid Instructions

1.1 Introduction

Rural Movement Organization (RMO) is an Afghan NGO with headquarters (HQ) in Kabul. It was established in 2014 as the continuation of the Belgian NGO "Solidarité Afghanistan Belgique" (SAB).

RMO retains the former national SAB management, key technical and administrative staff, and other SAB assets and maintains SAB expertise. It, therefore, is the trusted depository of SAB's nearly 30 years of experience and can smoothly continue all projects initiated under SAB management and take on any new challenges, while assuring the same project quality in these fields as SAB had provided for nearly 30 years.

In 2016, RMO formally became Geres (an international NGO) partner and jointly implemented a number of projects on energy, energy efficiency, environment, and climate change sectors.

1.2 Bid Instructions

- 1.2.1 The procedures and requirements presented in this invitation to bid are mandatory. The following general directions must be observed:
- Specific requested details and documents according to this tender form must not be omitted.
- All prices must be given in AFN.
- 1.2.2 The supplier should provide its most competitive rates according to the goods described in the tender form.
- 1.2.3 The supplier must provide supporting documents, including government licenses and client accreditations regarding similar tenders over the past three years.
- 1.2.4 Details of current and previous clients should be submitted.
- 1.2.5 Quality of procured items will be checked and verified by RMO staff to ensure that it meets the required specifications in the tender documents.

1.3 General Conditions

- 1.3.1 The winning supplier will be responsible for compliance with all national and local laws, and if required, clearance of any customs documents.
- 1.3.2 The winning supplier shall not sub-contract in whole or part any part of the contract without prior RMO written approval. RMO written approval does not relieve the winning supplier from any liability or obligation under the contract.
- 1.3.3 RMO will notify the winning supplier through a letter of intent, signed by the authorized RMO representative. The winning supplier is required to accept and sign the letter of intent within the specified time period.
- 1.3.4 Bids must be valid for a minimum period of 20 days from the date of opening of all bids.
- 1.3.5 All the pages/documents of the submitted tender must be dated and include the supplier's signature.

The pages/documents should be in one ink and easy to read. Any handwritten corrections to any pages/documents should have the supplier's initials and date.

1.4 Other Conditions

- 1.4.1 Prices should be quoted both in figures and in words. If the quoted rates are different when comparing the figures with the words, the prices written in words will be taken as final.
- 1.4.2 RMO reserves the right to reject or accept any or all tenders without assigning any reason.
- 1.4.3 goods will be delivered to the RMO office by RMO in three different packages which will be set out by RMO at the contract time.
- 1.4.4 Delivery of goods must include a signed and stamped invoice to RMO along with any supporting documents.

1.5 Payment Procedures

- 1.5.1 The invoice presented to RMO must be complete for all supplied goods. RMO will make payment after proper inspection of all goods and invoice verification within fifteen (5) days from the date of receipt of the goods with an invoice.
- 1.5.2 RMO will deduct/withhold the tax amount from the payment according to the Afghanistan Revenue Department requirements, providing the winning supplier with a copy of the tax payment receipt.
