

## Request for Quotations (RFQ 3009)

Jhpiego is seeking qualified vendors to obtain quotation(s) for procurement of internet connection contracts for the 28 ECHO sites in Kabul, Mazar-e-Sharif, Herat, Jalalabad, and Kandahar provinces, for more details see Annex B below.

### **Applicant Illegibility:**

- The potential vendors must be registered with the government of Afghanistan and have a valid Business license. A Vendor's current and valid Business License must be attached to its quotation.
- The potential vendors must attach Official Bank Account information with the same name as it is stated in the Vendor's AISA or business license and must confirm acceptance of payments through bank transfer.
- The potential vendors must accept tax withholding based on Afghanistan Tax Law.
- All the costs should be stated in Local currency (AFN) any quotations submitted in other currencies will automatically be disqualified.
- The Potential vendors must submit a copy of their Tax Identification Number (TIN) letter.

### **Selection Criteria:**

- **Technically Acceptable:** The selection will be with best value price and meeting the technical specification listed under the scope of work and technical specifications (Annex B). It is important that vendors mention the model and type in the column provided in the table. Additionally, vendors must provide details on the internet bandwidth availability and include a diagram of the primary route of the ISP and the backup route.

#### **Score 60**

- **Warranty:** Vendors should provide a warranty statement. Vendor warrants and implies that all goods and services delivered or provided hereunder are merchantable and fit for use for the particular purpose described in the RFQ. All equipment shall have the standard manufacturer's warranty **Score 20**
- **Delivery Time & vendor past experience:** Vendors should confirm the delivery time (in calendar days) for providing the requested items at the due location mentioned in this RFQ after receipt of the purchase order.

#### **Score 20**

Total Technical Score: **100** Minimum Technical Score required: **80**

- Vendors who score **80** and has the lowest price will be selected

**Important Note:** If the above-mentioned conditions are not met and the documents are not submitted along with the quotation, the quotation will be disqualified and will not be further evaluated.

LPTA: The selection will be made based on the lowest price and best quality products offered. A final determination will be made after the vendor's relevant experience, capacity to deliver, and supply chain are assessed.

The selected vendor will be awarded a fixed price contract resulting from this solicitation to the responsible Vendor/s whose quotation conforms to this solicitation and will be most to the project, price, and other factors considered.

Jhpiego anticipates that this RFQ will result in a single award to a single Vendor; however, Jhpiego reserves the right to make multiple awards, if it is in the best interest of the project.

**Penalty Charges:** Jhpiego will add a clause to the purchase order as the result of this RFQ and may deduct a sum of up to 2% of the Order's total value for each day of delay beyond the agreed delivery time until the actual goods/services are received.

**Payment:** Jhpiego will only make payment to the selected vendor's-maintained Bank Account after the delivery and acceptance of the required Goods/Services by Jhpiego.

Vendors are requested to submit their complete quotation to the Jhpiego office in hard copy by no later than **Aug 04, 2024, (2:00 p.m. Kabul, Afghanistan local time)**. To Jhpiego office located in Wazir Akbar Khan Street 15 roundabout, next to the Grill restaurant, in front of AWCC office.
