YVO needs Poultry and Poultry Farm Materials for a Project in Nangarhar Province, and invites interested parties to submit their sealed offers for the required items brought up in Annex (A). The offers must reach to YVO Main Office Admin/Logistics Unit located in (House# 07, Arbapan Babaryan Street No. 23, Adjacent to Babaryan Park, PD3, Jalalabad, Nangarhar Province) till 4:00 pm August 29, 2024.

Please check Annex (A) for detailed quantity and technical specifications.

**Terms and Conditions for the bid winner/participants**

1. Delivery and distribution locations of Poultry and Poultry Farm Materials are in Kot and Batikot Districts of Nangarhar Province.
2. Payment will be made within 20 Working days after inspection and complete delivery.
3. Prices shall be given in Afghanis (AFN) and must include all duties, transport cost, loading and unloading costs. Offers without sign and stamp will not be accepted. Manipulated/ overwritten offers will automatically be rejected. Supplier shall submit the price quotes in their own letterhead as well
4. All Poultry and Poultry Farm Materials must be according to YVO Technical Specifications mentioned in Annex (A).
5. If the poultry delivered from other provinces, at least 10 days' rest should be given in Nangarhar Province before distribution in a well quarantined and safe farm/hall.
6. The Poultry should be distributed in dis-infected plastic cages. The cages will be returned back to the contractor.
7. Mortality occurs within two weeks (15 days) after

2. د پيسو تاديه به د تخينكي كمپټي د تصديق وروسته په ۲۰ كاري ورځو په موده كې اجرا كيږي.
3. داوطلبان بايد خپل قيمتونه چې ماليات ، د انتقال ، بار او تخليه مصارف شامل وي په افغانيو ترتيب كړي. قيمتونه چې مهر او امضاء ونلري د پروسې څخه اخراج كيږي. افرونه بايد قلم خوري ونلري. ددې شرطلپانې سره ، نرخونه بايد د شركت په رسمي پېد كې هم وركړل شي.

<p>distribution should be compensated by re-distributing the Poultry according to the number of died Poultry.</p> <p>8. Quotations should be valid for 60 working days.</p> <p>9. YVO and the Directorate of Agriculture Irrigation and Livestock (DAIL), Nangarhar will carry out inspection of all Poultry and Poultry Farm Materials before and after delivery, and will reject any items that are not conforming to the given specifications and YVO requirements.</p> <p>10. The poultry feed will be analyzed and tested by the laboratory of the Ministry/Directorate of Agriculture, Irrigation, and Livestock before distribution, and it will be distributed only after receiving the approval letter.</p> <p>11. In case of delay without logical reasons in delivery of Poultry and Poultry Farm Materials, 0.5% of total cost of undelivered item/quantity will be charged as a penalty for each day of delay.</p> <p>12. 2% Tax will be applicable on the companies that has valid business license and 7% Tax will be applicable on the companies that have invalid business license, or on individuals who don't have business license, will be deducted from the contractor as a withholding tax and YVO will pay that amount to Ministry of Finance/provincial department, the amount starts from (1 AFN).</p> <p>13. The bid winner must deposit 10% amount of total contract value to YVO bank account as a Contract Performance Guarantee before signing the contract and the mentioned amount is refundable after successful completion of the contract.</p> <p>14. - Certify that proposed unit prices shall be fixed for the duration of the agreement.

- Transportation including Loading, unloading, distribution and other expenses are supplier's responsibility.
