- 1. The successful bidder must have the updated registration certification or and individuals must of national Electronic ID (Electronic Tazkira).
- 2. The successful bidder shall submit a copy of the company's registration certificate and Tazkira and individuals may be required to provide their E-Tazkira.
- 3. The Contractors shall be providing vehicles including drivers to the SFL for the period specified time.
- 4. The model of the Corolla vehicle should not be less than the year 2000.
- 5. Provided vehicles must have A/C and Heater systems.
- 6. The supplier should have prior experience with UN agencies or international organizations.
- 7. The vehicle driver must have a valid driving license.
- 8. The driver must have at least five years of driving experience.
- 9. The driver must have good ethical behavior.
- 10. During the period of this lease, the lesser bears the responsibility of providing fuel.
- 11. The lesser is responsible for the following severances of the vehicle including but not limited to: (repairing, changing of oil and filters, and periodic maintenance services).

- 12. During the duty if any contracted car is broken the lesser is responsible to provide another car so that no gap appear in our field operation.
- 13. There is no limit to the mileage of the vehicle. The vehicle can be operated anywhere inside of project area.
- 14. If the rental vehicle specified herein will be lost, theft, stolen and or damaged for any reason, the lessee will NOT be responsible.
- 15. Advance cash deposit: The awarded winner of the contract must pay 5% of the total amount of budget to the finance department of SFL upon signing the contract. This amount will be reimbursed after ending of the contract.
- 16. The vendor is required to pay the sales and service tax in accordance with the income tax laws of the Islamic Emirate of Afghanistan to the Finance department before receiving payment from SFL and must submit a copy of this receipt to SFL.
