<b>Operational Context and Objectives:</b>  Afghanistan is one of the world's most complex humanitarian emergencies, driven by decades of conflict, climate change and natural disasters, socio-economic consequences of COVID-19 and financial system shocks precipitated by the change in leadership in August 2021 compounded by pre-existing dire socio-economic conditions in the country.  These conditions have adversely impacted the overall well-being of displaced groups (refugees, asylum seekers, IDPs, IDP returnees, and refugee returnees) as well as vulnerable host communities resulting in increased recourse to harmful coping mechanisms to fulfil their basic

needs including early/child and forced marriages, child labour, irregular migration, substance abuse, resort to illegal or exploitative forms of labour among others.

In the Afghan context, in situations of conflict-induced displacement (both internal and across borders), following return from countries of asylum during the initial stages of the reintegration process, and in a consequence of widespread humanitarian needs, many community safety networks are broken down or are not accessible. Displacement and crisis, therefore, become the cause of new risks, affecting particularly the most vulnerable segments of the population. Services provided by government institutions often lack the necessary equipment, outreach capacity and resources to provide adequate support and social protection.

The cash-based interventions are part of strengthening the Protection Environment for the people we serve including refugees and asylum-seekers, refugee returnees, internally displaced persons (IDPs), IDP returnees and vulnerable members of host communities which is implemented either by UNHCR contracted Money Service Providers (MSPs) or implementing partners. Additionally, UNHCR delivers Non-Food Items (NFIs) through implementing partners to the most vulnerable population during emergencies.

The selected partner will be responsible to conduct:

- Distribution of Non-Food Items (NFIs)
- Transport and distribution arrangement of NFIs.
- Manage and organize Cash-Based Interventions (CBIs) distribution at UNHCR Encashment Centres and other distribution points across the selected provinces in the 20 Priority Areas of Return (PARRs).
- Direct delivery of cash to PSN and Legal Assistance (limited cases)

#### Expected results:

##### **Outcome Area 8: Well-Being and Basic Needs**

**Outcome Statement:** More IDPs, asylum-seekers, refugees and returnees have access to services that meet their basic needs.

**Output Statement:** Returnees (Refugees and IDP) are provided with basic support.

**Output Statement:** IDPs are provided with basic support.

**Output Statement:** Refugees and asylum seekers are provided with basic support.

UNHCR Afghanistan is dedicated to delivering a range of targeted cash interventions to address the diverse needs of refugees, asylum seekers, IDPs, IDP returnees, and refugee returnees and vulnerable host communities, with a primary focus on providing cash assistance and CRI. These assistances aim to promote the self-reliance, dignity, and sustainable reintegration of beneficiaries, enabling them to meet their basic needs and build resilience in the face of displacement.

Through various cash assistance and in-kind programs, UNHCR aims to achieve improved socio-economic and protection outcomes for beneficiaries, enhancing their resilience and contributing to durable solutions to displacement. The outputs encompass a wide range of interventions, including support for small and medium enterprises, facilitation of job placements, implementation of cash-for-work programs, provision of assistance for higher education, and support for shelter-related needs.

Additionally, UNHCR will provide multipurpose cash assistance to facilitate the reintegration of internally displaced persons (IDPs) and refugee returnees, support which contributes to sustainable voluntary repatriation return and reintegration efforts, and address the specific needs of forcibly Afghan returnees, IDPs and returnee individuals. These interventions will be



implemented across various regions of Afghanistan, targeting vulnerable populations including women, children, elderly persons, persons with disabilities, and marginalized groups.

Through these efforts, UNHCR seeks to provide comprehensive support to refugees, asylum seekers, IDPs, IDP returnees, and refugee returnees) and vulnerable host communities in Afghanistan, empowering them to rebuild their lives and pursue sustainable futures.

The selected partner will perform the following activities:

- Facilitate the CBI distribution in UNHCR 5 encashment centres.
- Arrange/manage the venue and facilitate the Cash-Based and CRIs distributions in PARRs and out of PARRs areas.
- Conduct On-site monitoring of CBI and CRI distributions.
- Coordinating distribution of CBIs and CRIs with local authorities, communities and beneficiaries
- Effectively maintain coordination with UNHCR contracted financial service provider and other partners for the distribution of CBIs and CRIs.
- Coordination with UNHCR contracted 3<sup>rd</sup> party monitoring partner for the conduct of Post-Distribution Monitoring and other monitoring activities.

To ensure the adequate protection of forcibly displaced and stateless persons, UNHCR requires partners to adhere to applicable sector standards outlined within [UNHCR's areas of specialization](#).

UNHCR is accountable for the personal data processing including the responsibility for addressing requests by data subjects relating to their data subject rights. 
