[INTRODUCTION]

The Sample Bidding Documents in this publication have been prepared for use by Procuring Entities in the procurement of Services by International Competitive Bidding (ICB), Single source (SS), Restricted Bidding (RB) and also These documents may also be adapted to National Competitive Bidding (NCB) with some changes generally necessary in the Instructions to Bidders and the Conditions of Contract.

Care should be taken to check the relevance of the provisions of the standard documents against the requirements of the specific Services to be procured. The following directions should be observed when using the documents:

- (a) All the documents listed in the Table of Contents are normally required for the procurement of Services; however, they should be adapted as necessary to the circumstances of the particular Project.
- (b) Details to be provided by the Employer prior to release of the bidding documents are limited to the Invitation for Bids (User's Guide), Instructions to Bidders (Section 1), Bidding Data Sheet (Section 2), and Special Conditions of Contract (Section 7), in addition to Sections 5 and 8, which deal with Activity Schedule, Performance Specifications and Drawings, respectively. **Specific details** should be furnished in the spaces indicated by italicized notes inside brackets. Those details not filled in by the Employer are the responsibility of the Bidder.
- (c) These Sample Bidding Documents are intended to serve on a repetitive basis in the GAAC Holding PD of the Project. Modifications to address specific Project or Contract needs should be provided only in the Special Conditions of Contract as amendments to the Conditions of Contract. If modifications must be made to the bidding procedures, they can be presented in the Bidding Data Sheet.
- (d) The foot-notes and the italic texts between brackets are not part of the text, but rather contain instructions for the user, as does and this Introduction. **They should not be incorporated in the bidding documents**. The cover should be modified as required to identify the bidding documents as to the names of the Project, Contract, and Employer, in addition to the date of issue.
- (e) The standard documents have been prepared for bidding where postqualification applies; adaptations are necessary to ITB Clause 4 and corresponding Bidding Data Sheet, and Forms when prequalification has taken place. The process of prequalification of bidders is not covered in these standard documents.]

SUMMARY DESCRIPTION

These Standard Bidding Documents for Procurement and its User's Guide apply either when a prequalification process has taken place before bidding or when a prequalification process has not taken place before bidding (provided alternative documents should be selected as applicable). 			(b) if the context so requires, "singular" means "plural" and vice versa;		
			(c) "day" means calendar day.		
2.	Source of Funds	2.1	The Employer guarantees that adequate funds have been budgeted and allotted and are also available for managing the procurement proceedings toward the cost of the project The Purchaser intends to apply a portion of the Project funds as to eligible payments under the contract for which this Bidding Documents are issued.		
3.	Eligible Bidders	3.1	The bidder and his / her partners have the citizenship of any country by observing, restrictions in the BDS. If the bidder, contractor and a subcontractor, resident, or registered in a country or operates in accordance with the laws of that country, he is considered a citizen of that country. The origin of any materials, equipment, and services to perform this contract are eligible from the country. Any materials, equipment, and Services to be used in the performance of the Contract shall have their origin in eligible source countries.		
		3.2	All bidders shall provide in Section 3, Bidding Forms, a statement that the Bidder, directly or indirectly, with the consultant or any other entity that has prepared the design, specifications, and other documents for the Project or being proposed as Project Manager for the Contract. A firm that has been engaged by the GAAC PD to provide Consultant Services for the preparation or supervision of the Services, and any of its affiliates, shall not be eligible to bid.		
		3.3	Strictly prohibited to make any withdrawal from the project budget for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import, to the knowledge of

			(i)	information regarding any litigation, current or during the last five (5) years, in which the Bidder is involved, the parties concerned, and disputed amount; and

		4.3 In procurement of renting properties different criteria may not be

- 4.4 Bids submitted by a joint venture of two (2) or more firms as partners shall comply with the following requirements, unless otherwise stated in the **BDS**:
 - (a) the Bid shall include all the information listed in ITB Sub-Clause 4.2 above for each joint venture partner;
 - (b) the Bid shall be signed so as to be legally binding on all partners;
 - (c) the Bid shall include a copy of the agreement entered into by the joint venture partners defining the division of assignments to each partner and establishing that all partners shall be jointly and severally liable for the execution of the Contract in accordance with the Contract terms;
 - (d) one (1) of the partners shall be nominated as being in charge, authorized to incur liabilities, and receive instructions for and on behalf of any and all partners of the joint venture; and
 - (e) the execution of the entire Contract, including payment, shall be done exclusively with the partner in charge.
- 4.5 To qualify for award of the Contract, bidders shall meet the following minimum qualifying criteria:
 - (a) annual turnover volume of Services of at least the amount **specified in the BDS**;
 - (b) experience as prime contractor in the provision of at least one (1) service contracts of a nature and complexity equivalent to the Services over the last five (5) years (to comply with this requirement, Services contracts cited should be at least seventy (70) percent complete) as specified in the BDS; the contract under dispute or the dispute amount is 10 present of total contract price shall not have considered as a similar experience.
 - (c) liquid assets and/or credit facilities, net of other contractual commitments and exclusive of any advance payments which may be made under the Contract, of no less than the amount specified in the BDS.
- 4.6 The GAAC Holding may determine qualification criteria renting proprieties according to the nature of the procurement determined.

		4.7	The figures for each of the partners of a joint venture shall be added together to determine the Bidder's compliance with the minimum qualifying criteria of ITB Sub-Clause 4.4(a), (b) and (e); however, for a joint venture to qualify the partner in charge must meet at least forty (40) percent of those minimum criteria for an individual Bidder and other partners at least twenty-five (25) percent of the criteria. The total eligibility figures of the partners must meet at least (100) percent of the eligibility criteria. Failure to comply with this requirement will result in rejection of the joint venture's Bid. 4.8 Subcontractors' experience and resources will not be taken into account in determining the Bidder's compliance with the qualifying criteria, unless otherwise stated in the BDS .		
5.	One Bid per Bidder	5.1	Each Bidder shall submit only one (1) Bid, either individually or as a partner in a joint venture. A Bidder who submits more than one (1) Bid (other than as a subcontractor or in cases of alternatives that have been permitted or requested) will cause all the proposals with the Bidder's participation to be disqualified.		
6.	Cost of bidding	6.1	The Bidder shall bear all costs associated with the preparation and submission of his Bid, and the Employer will in no case be responsible or liable for those costs.		
7.	Site Visit	7.1	The Bidder, at the Bidder's own responsibility and risk, is encouraged to visit and examine the Site of required Services and its surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the Services. The costs of visiting the Site shall be at the Bidder's own expense.

The Employer will respond to any request for clarification received earlier than four (4) days prior to the deadline for submission of bids. The purchaser must respond to any request for clarification within 2 days of receipt. Copies of the Employer's response will be forwarded to all purchasers of the bidding documents, including a description of the inquiry, but without identifying its source.

Bidders are encouraged to attend the meeting if it is held. The Bidder is requested to submit any questions in writing so as to reach the Employer not later than five (5) days prior to the date of the meeting. Minutes of the pre-Bidding meeting, including the text of the questions raised and the responses given, together with any responses prepared after the meeting, will be transmitted within five (5) days to all those who purchased the Bidding Documents.

The request for clarification and the response shall be in writing or by email, telex, or facsimile, but no change in the price or substance of the Bid shall be sought, offered, except as required to confirm the correction of arithmetic errors discovered by the Employer in the evaluation of the bids. Section 6 General Conditions of Contract

1. GENERAL CONDITIONS

1.1 Definitions

Unless the context otherwise requires, the following terms whenever used in this Contract have the following meanings:

- (a) The Adjudicator is the person appointed jointly by the Employer and the Contractor to resolve disputes in the first instance, as provided for in Sub-Clause 8.2 hereunder.
- (b) "Activity Schedule" is the priced and completed list of items of Services to be performed by the Service Provider forming part of his Bid.
- (c) "Completion Date" means the date of completion of the Services by the Service Provider as certified by the Employer.
- (d) "Contract" means the Contract signed by the Parties, to which these General Conditions of Contract (GCC) are attached, together with all the documents listed in Clause 1 of such signed Contract.
- (e) "Contract Price" means the price to be paid for the performance of the Services, in accordance with Clause 6.
- (f) "Day works" means varied work inputs subject to payment on a time basis for the Service Provider's employees and equipment, in addition to payments for associated materials and administration.
- (g) "Entity" The party to the contract contents of special condition of the contract.
- (h) Day: Means the calendar day.
- (i) "Foreign Currency" means any currency other than the currency of the Islamic Republic of Afghanistan.
- (i) "GCC" means these General Conditions of Contract.
- (k) "SCC" means these Special condition of contract.
- (I) "Government" means the Government of the Islamic Republic of Afghanistan.
- (m) "Local Currency" means the currency of the Islamic Republic of Afghanistan.
- (n) "Member," in case the Service Provider consist of a joint venture of more than one entity, means any of these entities; "Members" means all these entities, and "Member in Charge" means the GAAC Holding specified in the SCC to act on their behalf in exercising all the Service Provider' rights and obligations towards the Employer under this Contract.
