We require fuel delivery to two locations:Dedicated Fuel Station: This is for our vehicles, which refuel at this station KDH, HRT, and JAA.DRC Compound: This is for the generators located at the compound.
2	25-09-2024	Storage Capacity: I would appreciate clarification on the Said DRC Delivery Location Storage Capacity and frequency of Delivery according Average fuel Consumption to understand our resource engagement.	We have a fuel tank at our Country Office with a capacity of approximately 9,000 liters, from which we typically order around 6,000 liters per delivery as needed. Additionally, ou guest house is equipped with a 7,000-liter fuel tank, where we also order about 6,000 liters per delivery. In our Kabul
			Area Office, we have a larger tank with a capacity of around 20,000 liters. For other locations, we generally order aroun 2,000 liters of diesel fuel as needed for our generators.

Could you please clarify if diesel is also required?	We required diesel fuel from fuel station as well in DRC Kandahar, Herat, Jalalabad and Kunar.

6	25-09-2024	Diesel Fuel Density: The ITB package specifies a diesel fuel density of 830+. However, this year, the density is around 820+.	The diesel fuel L62-02 has a density of 830+ at 15°C.
7	25-09-2024	Contract Amendment for Price Fluctuations: Is it possible to amend the contract to allow for price adjustments if the price changes by 10% instead of the current 15% threshold?	No, 15% is applicable.
