In case any birth kit is damaged during the way, Op Mercy will bear no cost.</p> <ul style="list-style-type: none"> • Bidders shall submit Bids physically as original hard in a sealed envelope to Op Mercy main office in Mazar. The hard copy attached quote shall include the ITB number, title, and closing date. • The quote submitted shall be valid for a period of at least 30 days. • Bidders shall sign and date their Bid. • The rates quoted shall be for the complete service inclusive of all taxes. Valid update license from AISA or Ministry of commerce 2% tax will be dedicating from the total price and one copy will provide to the supplier. In case if the company license is expired 7% tax will be deducted from total amount • All prices shall be quoted in AFN only other currency quote will not be considered. • We reserve the right to inspect specified items included in the bid before purchase. • No offer, payment, consideration or benefit of any kind, which could be regarded as an illegal or corrupt practice, shall be made, promised, sought or accepted - neither directly nor indirectly - as an inducement or reward in relation to activities funded under this agreement, incl. tendering, award or execution of contracts.
