5) Schedule of Requirement / Scope of Work

- Ten rental vehicles are required. Contracts may be arranged on either a daily or monthly basis, depending on operational needs. Please provide both daily and monthly rates in ANNEX 1: Bill of Quantities (BoQ).
- Prices should include all associated costs, including fuel, driver, and maintenance.
- All rental vehicles must be fully operational.
- Vehicle Type: Hilux Model 1984 or any similar operational vehicle
- The vehicles will support the ABCO team during site visits, traveling to villages in the Daychopan and Kakar districts of Badghis province.
- The **daily travel distance** may vary, so we request flexible arrangements based on site-specific travel requirements.

6) **Payment Terms**

- All duties, taxes and other payable will be paid by the contractor under the contract, shall
 - \circ be included in the total bid price submitted by the bidder.
- ABCO will deduct the applicable tax (2% of the total payable) as required by Afghanistan tax Law and will make the direct deposit to the Da Afghanistan Bank and make a clearance with the Ministry of Finance at the end of the year.
- Payment will be made within 15 days of the supplier's invoice submission in cash.
