In order to get a better understanding to the reservoir and collect necessary parameters for the development, AfgChin is planning to take about 140m cores at well Kash-24, Aq-11 and two exploration wells in 2024 work program. And core lab analysis service is required to fulfill the purpose, including but not limited to porosity, permeability, water saturation, thin slice analysis, cast slice analysis, sem, ct scanning, granularity analysis, heavy mineral analysis, rock resistivity analysis, permeability in overburden pressure condition, porosity in overburden pressure condition, porosity of whole diameter samples, permeability anisotropy of whole diameter samples, rock mechanic parameters, rock chemical analysis, enclosure measure, x-diffraction, sensitivity analysis, wettability analysis, oil & water relative permeability, conventional displacement test and etc.
