RFQ purpose:

GSRO invites quotations from qualified and experienced vendors/suppliers with the expertise and capacity to supply and deliver **chickens**, **veterinary medicines**, **and poultry care items** in accordance with the specifications outlined in this RFQ. As part of the **Women Empowerment through Climate-Smart Agriculture and Agribusiness** initiative, funded by UN Women, GSRO plans to procure these items for delivery to Pashtun Zarghon district, Herat Province. This initiative aims to enhance rural livelihoods and empower women through sustainable agricultural practices.

Instruction to bidders

Submission of offers

Eligible suppliers should submit their offers directly to the main office of GSRO at House #16, Ebn-e-Sina 8, 1st District, Herat, Afghanistan. Bidders must submit their offers in-person no later than 17 December, 2024, as online submissions are not acceptable.

Offer Format

Bidders are requested to submit their offers in accordance with the instructions and requirements described in this RFQ. Failure to adhere to these instructions or requirements may lead to disqualification of a quotation from evaluation.

Inspection: The Poultry Care and Supplies package will be inspected by the GSRO technical team. Poultry Care and Supplies that do not meet the Minimum Specification will be rejected.

Bidders' determination of responsibility.

- a. Bidder cannot submit more than one offer per business license. Also, if one person holding key roles in more than one company submits multiple offers from various addresses for this RFQ, all such offers will not be considered for evaluation.
- b. Bidders should hold valid business licenses with the commerce and industry ministry.
- c. Offers and queries should be submitted in English and evaluations will be made in English and English will take precedence over Dari and Pashto proposals/quotations.
- d. Rates shall be provided in both words and figures. All rates/charges should be stated in Afghani (AFN)
- e. The offers in response to this RFQ must include all prices including all relevant taxes as per Afghanistan Income Tax Law, GSRO will not accept any additional taxes or charges to the awarded entity after an award is made. According to Afghan Income Tax Law, GSRO will withhold 2% of the total amount from the supplier who holds valid registration licenses with relevant Afghan Ministries and remit the amount to the Ministry of Finance.
- f. Payments will be made to the supplier only by Cheque or Bank Transfer, GSRO will pay the supplier in accordance with the payment schedule, to be stipulated in the Purchaser Order Agreement or contract.
- j. Incomplete or non-compliant offers will not be considered.
- k. Offer must be valid for 60 days from the date of submission and fixed for the total duration of the contract.
- I. GSRO reserves the right to reject the product supply if it doesn't meet the required specifications described in this solicitation.
- m. Clear description of business references and experience will be positively marked as per the template provided.
- n. **Offerors are required to carefully read all instructions** and the specifications contained in this Request for Quotation. The completion and submission to GSRO of the above item will constitute a Quotation and will indicate the Offeror's agreement to the terms and conditions in this RFQ and in any attachments hereto.
- o. The supplier will deliver the required Poultry Care and Supplies in **Pashtun Zarghon** district, of the Herat province as per the GSRO distribution plan. **The planned distribution sites i.e. five villages will be determined upon signing contract.**
- p. Issuance of this RFQ in no way obligates GSRO to award, and offers will not be reimbursed for any cost associated with the preparation of this Quote. GSRO also reserves the right to issue multiple awards and procure only items or services from the selected vendor(s).
- q. RFQ must be signed and stamped.
- r. If you are approached by anyone suggesting unlawful actions regarding this RFQ or have any concerns or suspicions that your offers are not being treated with honesty, transparency, and integrity, please email to <u>complaint@gsro.org</u>, or call 0793719719. General Terms and Conditions

The general conditions form attached to this RFQ must be read, signed, stamped, and submitted by the supplier along with the offer response.

- a. GSRO reserves the right to waive any administrative requirement in this RFQ.
- b. GSRO will have the right to carry out due diligence (confirmation of information provided or clarification) on any offer received.
- c. GSRO will not share its internal evaluation documents.

Questions

Offerors are welcome to seek clarifications or ask questions about the technical and administrative aspects of this RFQ. All questions or requests for clarification must be in English. Questions or requests for clarification should be submitted to the email: procurement@gsro.org before the deadline for questions i.e. 13 Dec, 2024. Offerors should be aware that their responses to questions or requests for clarification may be shared with other Offerors.

Any verbal information received from employees of GSRO, the Beneficiary, or any other entity should not be considered an official response to any questions regarding this RFQ.

Prices

Quoted prices should be firm, fixed, and all-inclusive. No additional sums will be payable for any change or escalation in the cost of materials, equipment, packaging or labor, warranty-related costs, all other costs and charges of whatever description or amount in connection with, necessary for, or resulting from the Offeror's required performance. Price(s) must include all taxes required by the country in which the business operates. GSRO will not accept any additional taxes or charges after any resulting award.

Packaging:

The beneficiaries will receive a package containing 40 chickens as well as the required medicine, all of which require specialized packaging. It is the responsibility of the Offeror to ensure that the packaging is designed to protect the items/products from damage, preserving their quality and ensuring safe delivery to the beneficiaries. GSRO reserves the right to provide feedback on or reject the proposed packaging if it does not meet the required standards.

Delivery

The delivery of the Poultry Care and Supplies by the selected vendor will be made to the Pashtun Zarghon district, as planned in 5 villages (names of villages will be determined in the contract) with the coordination of the GSRO procurement team. GSRO's responsibility is to distribute the items for the beneficiaries in each village based on the predefined schedule which is shared in advanced with the Offeror.

Evaluation and Award

The award will be made to a responsible offeror whose offer follows the RFQ instructions:

- 1. meets the requirement of the evaluation
- 2. Obtains the minimum score (40 scores out of 60). The best offer based on the lowest price and technically acceptable will be selected among those offers that obtain at least 40 scores or more than that, out of 60 scores.

Please note that if there are significant deficiencies regarding responsiveness to the requirements of this RFQ, an offer may be deemed "non-responsive" and thereby disqualified from consideration. GSRO reserves the right to waive immaterial deficiencies at its discretion.
