### Specific Rules and Conditions for this RFQ

- Any participating Bidder must be legally licensed and registered in Afghanistan!
- Any quotation submitted after the deadline will not be considered!
- This is not a tender, hence no open tender meeting will be held. Medair will contact only short-listed Bidders!
- Medair reserves the right to choose a Service Provider based on specific factors including but not limited to; best price, quality, reliability and past experience among others.
- **For this RFQ, the bid analysis will be processed in 2 Phases;**
  - **The 1st Phase will involve Pre-Bid evaluation where all bids received will be subjected to a screening process based a 10 point criteria.**
  - **Any bidder scoring 70% and above will be considered for 2<sup>nd</sup> Phase bid valuation to determine a winner(s). Under the Second Phase, the main selection criteria will be based on the following factors: Validity and Authenticity of the Company Registration documents, and years' experience providing Good and uninterrupted Internet services to other INGOs in Uruzgan.**
- According to requirements Medair reserves the right to accept or reject any quotation or cancel the process without any obligation to give reasons for acceptance, rejection or cancellation to the affected or interested Service Providers.
- Medair reserves the right to split the offer into different lots and to award contracts to multiple qualified Service Providers.
- All Medair and its Donor terms, conditions and policies must be accepted by the Service Providers.
- Medair will not cover any cost related to the creation and submission of the Quotation, regardless of the result.
- Medair expects Service Provider(s) with whom it partners with to follow ethical business practices and be socially accountable. Those expectations are set out in Medair's Code of Ethics, which, along with the associated policies are available on Medair's website at <https://www.medair.org/accountability/>, and are subject to periodic updates.
- Afghanistan Government regulations require Medair to upload all relevant information, including copies of signed contracts, to the government database known as TAIS. The Service Provider should be in agreement with this requirement.
- The quote shall be minimum valid for 90 days after submission date.
- Monthly payment 30 days after submitting Invoice to Medair office.
- Payment by bank transfer is preferred (for cash payment Medair will deduct 4% commission fee from the payable amount)

- Medair is obliged by the Government of Afghanistan to pay Withholding Tax on behalf of Service Provider if a single invoice exceeds 50,000 AFA or if the total amount spent with one Contract within one calendar year will extend 50,000 AFA. For all registered Service Providers with TINs and Business Licenses, Medair will submit on behalf of the Service Provider 2% Withholding tax to the Government.

See below example on how Withholding Tax is calculated.

- a. *Invoice amount 100% - 2% withholding tax = 98% payable to Supplier (in case TIN and business license are available)*
- b. *Invoice amount 100% - 7% withholding tax = 93% payable to Supplier (in case TIN and business license are not available)*
