Jhpiego is seeking qualified vendors to obtain quotation(s) for procurement of internet connection contracts for the 28 ECHO sites in Kabul, Mazar-e-Sharif, Herat, Jalalabad, and Kandahar provinces, for more details see Annex B below.

Applicant Eligibility:

- The potential vendors must be registered with the government of Afghanistan and have a valid “business registration license” from the Afghanistan Central Business Registry & Intellectual Property (ACBR-IP) department of Ministry of Commerce and Industries (MOCI), and a copy of Business License must be attached with its quotation.
- The potential vendors must attach Official Bank Account information with the same name as stated in the Vendor’s business registration license and must confirm acceptance of payments through bank transfer.
- The potential vendors must accept tax withholding based on the Article 72 of the Afghanistan Income Tax Law.
- All costs should be stated in Local currency (AFN); quotations submitted in other currencies will automatically be disqualified.
- The Potential vendors must submit a copy of their Tax Identification Number (TIN) letter that must be in the name of the business

Selection Criteria:

- Past Experience: The ISP must have completed similar contract/s within the last three years. (A Copy of the Similar Contract must be provided)
- Installation Capacity: The ISP must confirm their ability to complete the installation of internet services at all 42 locations within a two-week timeframe.
- Service Specifications: The ISP must confirm that services will be provided in accordance with the specified requirements.
- Service Level Agreement: Service Level Agreement: The ISP must confirm a 99.8% up time in their Service Level Agreement.
- RTO (Recovery Time Objectives): within one hour for links IP and software issues and provide technical support within 24 hours for hardware issues.
- Network Operation Centers (NOC): The ISP must confirm the availability of NOC
- No Subcontracting: The ISP must agree not to subcontract any sites.
- Local Presence: The ISP must confirm their local presence in all provinces where internet service is required.
- Core Provider: The ISP must be the core provider of internet services and not merely a distributor.
- Backup Route: The ISP must have a backup route for internet services in all five provinces to ensure uninterrupted service.
- Direct Capacity: The ISP must confirm the availability of direct capacity for providing internet services and provide a primary route and backup route diagram.
- Network Monitoring: The ISP must agree to provide a network monitoring solution for all 42 sites.
- Required Equipment: The ISP must provide the following necessary equipment at all 28 ECHO sites, including routers, point-to-point antennas/ microwave antennas for 5 Jhpiego Sites / Point to point equipment for 9 Jhpiego sites, and any other equipment required for uninterrupted services.

Important Note: If the above-mentioned conditions are not met and the required documents are not submitted in accordance with Annex-A along with the quotation, the quotation will be disqualified and will not be further evaluated.

Source Selection Method:

LPTA: The selection process adheres to the Lowest Price Technically Acceptable (LPTA) methodology. This approach ensures that the selected vendor meets the minimum technical qualification requirements. The contract award recommendation will be based on the vendor’s technical qualifications and the submission of the lowest price. A final determination will be made after the vendor’s relevant experience and capacity to deliver are assessed.

The selected vendor will be awarded a fixed-price Technical Services Contract (TSC) with a duration of 6 to 9 months resulting from this solicitation to the Service Provider responsible whose quotation conforms to this solicitation and will be most advantageous to the project, price, and other factors considered.

Jhpiego anticipates that this RFQ will result in a single award to a single Vendor; however, Jhpiego reserves the right to issue multiple awards, if it is in the best interest of the project

Payment: Jhpiego will only make payment to the selected vendor’s-maintained Bank Account after the delivery and acceptance of the required Goods/Services by Jhpiego.

Quotation Submission in Hard Copy:

Vendors are requested to submit their complete quotation to the Jhpiego office in hard copy by no later than January 27, 2025 (4:00 p.m. Kabul, Afghanistan local time). To Jhpiego office located in Wazir Akbar Khan Street 15 roundabout, next to the Grill restaurant, in front of AWCC office.

Note: Quotations received by email or any other means than as stated above, and after the RFQ deadline will not be considered and evaluated.
