

Request for Proposal (RFP) for WPSO Annual and Project Audits

1. WPSO Introduction

Wellness Prosperity and Socio-Empowerment Organization (WPSO) is a non-profit organization registered with the Ministry of Economy under registration #3688, working nationally in Afghanistan. WPSO aims to promote well-being, prosperity, and socio-economic empowerment for vulnerable communities.

2. Scope of Services

The appointed firm will be responsible for conducting external audits for WPSO, which include both the **Annual Audit and a Separate Project Audit**. The audits must be carried out in accordance with international standards, donor guidelines, and Generally Accepted Accounting Principles (GAAP) or International Financial Reporting Standards (IFRS).

2.1 Annual Audit

- Audit Period: January 1, 2024, to December 31, 2024
- Audit Requirements:
 - a. Statutory audit of WPSO's financial statements for the specified year.
 - b. Evaluation of whether funds have been used in accordance with the conditions outlined in the grant agreements, emphasizing economy, efficiency, and purpose-specific use.
 - c. Verification that all necessary supporting documents, records, and accounts are maintained according to donor and statutory requirements.
 - d. Ensure compliance with the financial guidelines of any donor-funded programs and projects.

2.2 Project Audit for Grant Funded Program (Separate)

• Project Name: WYAPC

• Grant Amount: 224,151 USD

- Project Duration: August 1, 2023, to January 31, 2025
- Audit Period: For the period ending January 31, 2025, specifically for the project.

The project audit will be conducted separately from the annual audit and must comply with the donor's requirements:

- o The financial reports (interim and final) must be examined by a professional auditor.
- The audit should verify that the grant funds have been utilized as per the donor contract and in line with GAAP or IFRS.
- The auditor cannot be the same person who signed the financial reports or another authorized individual. The auditor should be independent and approved as per the donor's guidelines.
- The audit will also assess the economy, efficiency, and purpose-specific use of the grant funds.

3. Deliverables

The audit firm will be required to submit the following deliverables:

- For the Annual Audit:
 - o Draft Final Report (to be submitted by Feb 28, 2025)
 - o A formal Management Letter highlighting areas requiring attention.
 - o Final Financial Audit Report for WPSO for the year ending December 31, 2024.
 - o Invoice with detailed bank account information for payment.
 - One original signed copy of the final audit report.
- For the Project Audit:
 - Draft Final Report (to be submitted by February 15, 2025)
 - Final Audit Report for the project, including interim financial reports.
 - o Independent Auditor's Opinion on the project's financial statements and compliance with donor terms.

4. Shortlisting and Evaluation Criteria

The evaluation of proposals will consider the following:

- Price and Budget: Competitive and transparent pricing.
- Relevant Experience: Experience in auditing similar non-profit organizations and donor-funded projects.
- References: Two references from similar organizations that have received similar services in the past two years.
- Reputation: The firm's reputation in the market and within the auditing profession.

5. Confidentiality and Conflicts of Interest

- The selected firm must adhere to strict confidentiality regarding all information obtained during the audit process. Any conflict of interest must be disclosed.
- Auditing firms with direct ties to WPSO board members or staff are ineligible to apply.

6. Form of Tender - Information to be provided

To be considered for this tender, your proposal must include the following:

- Firm Profile:
 - A detailed description of your firm's services, including experience with similar nonprofit organizations.
 - A list of qualifications and certifications of the proposed engagement partner, including evidence of professional membership.
 - o Firm's organizational structure and staff qualifications.
 - Evidence of being part of an international audit network (top 10 networks preferred).
- Experience:
 - Specific details of experience in conducting audits for similar organizations, particularly in donor-funded projects.
 - CVs of key personnel who will perform the audit work.
- Quality and Standards:
 - Description of quality control procedures and performance standards followed by the firm.
- Cost Breakdown:
 - An itemized cost breakdown, including all applicable taxes under Afghan law (www.mof.af).
 - o An indication of expected fees for subsequent years or additional projects.
